## ASCA RALLY JUDGE APPLICANT QUALIFICATIONS

### A. Licensed Rally Judge:

1. Approved for a minimum of one year to judge all levels in one of the following recognized Rally Organizations: AKC, UKC, CKC, or APDT.

### B. Licensed Obedience Judge:

1. Licensed to judge through Open in one of the following recognized Rally Organizations: ASCA, AKC, CKC, or UKC.
2. One Rally Masters (RM) title from ASCA  
Or  
Two Rally Excellent (RE) titles. At least one RE title must be from ASCA. The other RE title can be from AKC, CKC, or the UKC URO3 or the APDT RL3.

### C. Other Person:

1. Show proof of completion of four ASCA Rally Stewarding assignments, at least two of which were serving as Table Steward for all Rally classes, with dogs entered at all levels, at ASCA Sanctioned trials, signed and dated by the Judge(s) for whom you stewarded. See pages 4 and 5 for Stewarding Assignment Worksheets.
2. Fulfill Option A or B listed below:

#### **Option A:**

- Two companion Dog (CD) titles from ASCA, AKC, UKC and/or CKC
- One Companion Dog Excellent (CDX) or Open Dog Excellent (ODX) title from ASCA, AKC, UKC and/or CKC
- One Rally Masters (RM) title from ASCA

#### **Option B:**

- One Companion Dog (CD) title from ASCA, AKC, UKC and/or CKC
- One Rally Excellent Masters (REM) title from ASCA
- Three Rally Excellent (RE) titles – at least one RE must be from ASCA. Others may be a combination from ASCA, AKC, CKC, the URO3 from IKC, and/or the APDT RL3

### All Applicants:

- Following verification of other registry licenses, titles and stewarding assignments (as applicable), the applicant will be sent a current copy of the ASCA Rally Rules and Regulations and the ASCA Rally Judge's Test.
- The test must be completed with 100% accuracy and may be retaken.
- Upon successful completion of the test, the applicant must submit a complete set of ASCA Rally Courses, for all levels, using the ASCA Rally Icons. A completed ASCA Rally Course Checklist must be submitted with the courses.
- All applicants must also complete the Judges Education Seminar online, or have completed the seminar at a live event sponsored and presented by ASCA within the 12 months preceding submission of their application.
- Other Person applicants must complete apprenticing requirements outlined on page 51 of the current Rally Rulebook.
- Guidelines for acceptance and continuing education requirements are found on pages 52-55 of the current Rally Rulebook.
