JUDGES ADDENDUM. Judges statement fro Obedience, Tracking, Agility, Conformation:

Judging at an ASCA sanctioned event is an honor and a privilege, not a right. Judge applicant must satisfy ASCA's stated minimum eligibility requirements for judges, but satisfying the minimum requirements does not

entitle an applicant to become or remain an ASCA judge. In addition to satisfying other stated qualifications to serve, an applicant must consistently display the highest level of ethical conduct, ASCA's

codes, rules, decisions and Statement of Purpose in ASCA's Bylaws. Any documented failure to perform on this level may result in denial or revocation of judging privileges or prior service. Approve: Unanimous. Motion carries.

93:17 STOCK DOG RULES- Duck Arena. Motion: Lori Middleton. Second: Maarten Walter. Motion: Change Chapter 3, Section 11 to read:

Duck arenas shall measure a minimum of 60 X 90 feet up to a maximum of 100 X 100 feet (plus or minus 5 feet in combined directions.) 7 minutes will be allowed for each run, with a 2 minute warning.

Change Appendix CII. Course A1.A to read: Arena: minimum
of 60 X 90 feet up to a maximum of 100 X 100 feet (plus or minus 5 feet in combined)

Change Appendix CII. Course A 1.C. Take Pen: located at end of arena opposite Obstacle 1 and 2, preferably outside the arena; 8 X 8 feet minimum up to a maximum 16 X 16 feet with the take pen gate a minimum of 8 feet.

Change Appendix CIII. Course B 1.A: minimum of 60 X 90 up to a maximum of 100 X 100 (plus or minus 5 feet combined).

Effective date of rule change: June 1, 1997 Approve: Unanimous.
