**Grounds and General Information:** Show will be outdoors on grass with limited shade. Canopies are recommended. Please do not leave any dog hair, trash or waste at the show site. You **MUST** clean up after yourself!

The Grounds open at 7:00 AM and close at 8:00 PM. Late or early arrive, contact show coordinator.

There will be no designated grooming areas; however, we ask that you do not set up ay spaces until after the club has set up the ring for the weekend.

All set ups must be at least 20 feet from ringside.

You cannot hook up dryers, etc to electrical spots. The electrical spots are for purchased RV sites.

No parking on the grass or ringside. You can unload ringside then you must return your car to the parking lot in front of the grounds at the entrance.

## **COVID 19 INFORMATION**

- **Masks will be required in accordance with State, County and/or City Ordinance, whichever is strictest. In the event the prevailing ordinance does not require masks to be worn, exhibitors will be required to wear masks while in the ring if required by conformation judge.**
- **No masks will be provided to exhibitors or spectators. You must bring your own mask/face covering (PPE) .**
- **Exhibitors will be required to read and sign a waiver in order to pick up arm band numbers of enter the ring.**
- **Everyone in attendance will be expected to maintain social distancing of at least 6 feet both in and out of the show ring. Individual set ups must be spaced a minimum of 6 feet apart.**
- **Spectators or individuals not directly involved in the showing of dogs each day should be kept to a minimum.**
- **Exhibitor is to be prepared to show the bite/detention to the judge.**
- **Exhibitors/Spectators showing any symptoms or with relatives showing symptoms must stay home and not participate in event.**
- **All entry forms must be completed prior to coming to the entry table. GCASC will provide extra entry forms at a table located away from the entry secretary, but will not provide any pens. Please ensure you bring a pen if entries need to be completed at the show.**
- **All exhibitors and spectators are expected to act in a responsible manner with regarding to social distancing, sanitizing of hands, and wearing appropriate face covering as outlined above. While hand sanitizer will be provided by GCASC for judges, stewards and volunteers, all exhibitors and spectators should bring their own hand sanitizer in the event extra is not available.**
- **GCASC along with Riverland RV Resort, owners and employees reserve the right to request anyone behaving in a reckless or inconsiderate manner as respects COVID-19 to leave the grounds. If this becomes necessary, no refund of entries will be made.**
