Utility B, Utility A, Open B (ODX/CDX), Open A (ODX/CDX), Novice B, Novice A (Group exercises will follow A and B classes may be combined), Beginner Novice B, Beginner Novice A (optional titling class).

Awards: Ribbons 1st - 4th place, and green qualifying ribbon, rosettes will be given for High in Trial Aussie, High in Trial Other Breed, High Combined and High in trial Jr.

ASCA Performance Titles. A tracking number is required for obedience competition. No dog without an ASCA individual registration, LEP number or ASCA tracking number may compete in any ASCA Obedience trial (A dog will be allowed to be shown at a trial where the handler applies for an ASCA tracking number).
