This show will be held under the current rules and regulations of ASCA.

No entry shall be accepted from a dog or handler disqualified from the ASCA conformation program; a dog or handler disqualified from all ASCA programs: or a person not in good standing with ASCA.

Classes offered and sequence of judging:

Jr. Handling: Pee-Wee 3-5, Sub Jr 6-7, 8-12 Novice, 8-12 Open, 13-17 Novice, 13-17 Open, BJH

Non-Regular Classes (Divided by Sex): 2-4 Month Puppy, 4-6 Puppy, BOB Puppy

Regular Altered & Intact (Divided by Sex): 6-9, 9-12, 12-15, 15-18, Novice, Am. Bred, Bred-By, Open (Divided by Color), Winners Dog, Winners Bitch, Best of Breed

Awards: Ribbons 1st – 4th Place, Rosettes, awards all shows, all days.

Facility Accommodations: The show will be held indoors on a carpet. The grounds will open at 8:00 AM for setup. Ringside seating is ok, but if you did not travel together please remain 6' apart. Indoor setups must be 6' apart. Building is climate controlled. Power will be limited, please bring your own generators if possible. No blowers inside the building.
