All entries must be completed and on ASCA forms. No entries will be refunded after entries have closed. Partial payments do not constitute a valid entry. 25.00 service charge for returned checks. No entry shall be accepted from a dog or handler disqualified from the ASCA conformation program; a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA. Entry fees will not be refunded in the event a dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by the Show Committee. Entry fees will not be refunded if the show cannot open or be completed due to any cause beyond the control of the Show Me State ASC.

Copies of the ASCA registration papers must be presented to Show Secretary, if requested, for any Australian Shepherd 6 months old and over. Exhibitors, through submission of their entry, acknowledge they are knowledgeable of ASCA rules and

regulations. No entry shall be accepted which specifies any conditions as to its acceptance.

The Show Me State ASC, its board and members, and Mutts Manners and More, LLC as such will not be liable for any loss or injury which may be sustained through disappearance, loss, theft, injury, and/or death of dogs entered in this event.
