Award restrictions: <u>For Exhibition Only</u> dogs do not qualify for any awards. Dogs may win only one award so we can share the glory. The word "Dog" indicates that it may be any herding breed or cross breed of herding origin as outlined and approved by ASCA. Bitches in heat will run in order.

Incomplete entry forms including registration numbers and entries received without registration papers will NOT be accepted. Please make sure your entry form includes the dog's call name and your e-mail address.

Handler's Meetings each day at 8:30 am - Run order posted daily

OTHER INFORMATION:

Entry fee refunds will be issued after close of pre-entries only if there is a waiting list and somebody takes your run.

Substitutions will be allowed only with a dog owned by the same person making the original entry.

Entry fees must be made by Check/Cashiers Check/Money Order.

Entries received without proper signatures, fees, information, etc. will be deemed incomplete and will not be accepted.

Registered Owner of dog shall be responsible for replacement cost of livestock at the following prices: DUCKS - \$75.00 per head, SHEEP - \$200.00 per head -unless participants are notified otherwise at trial time.

Confirmation of entries shall be made via email or self-addressed stamped envelope (if supplied).

Trial will fill on a first-come basis. The Trial Committee will draw run order prior to the trial.

Bitches in season will run in order.

This trial shall be run under all ASCA Rules and Regulations.

A \$50 service fee will apply to all returned checks. Returned checks will not constitute an accepted entry.

Weather: Please be prepared for any type of weather for both you and your dog. Bring shade and foul weather gear.

FACILITY: This is a private farm, so please treat it with respect. Do not park along the fence line on the left side of the driveway on Friday due to the influence you may inadvertently have on the stock. A toilet will be on site.

Directions to show site (75 County Road A074, Chaparral, NM 88081 – but beware the GPS!):

From Las Cruces:

Take I-10 to Exit 162 (Chaparral/Anthony/HWY404) – last exit out of NM. Turn left towards Chaparral and go until it deadends into the turnaround. Go left and take an immediate right onto Lisa. Go to DeLara Estates Drive (across from the Sheriff's office and Segura's Auto and turn right. Come down until it turns to dirt road and take the first real left after that onto County Road A074. Come down past the stop sign in the middle of the road staying to the right. House on the left – look for the dog signs.

From West El Paso:

Take I-10 to Exit 162 (Chaparral/Anthony/HWY404) – first exit in NM. Turn right towards Chaparral and go until it deadends into the turnaround. Go left and take an immediate right onto Lisa. Go to DeLara Estates Drive (across from the Sheriff's office and Segura's Auto) and turn right. Come down until it turns to dirt road and take the first real left after that onto County Road A074. Come down past the stop sign in the middle of the road staying to the right. House on the left – look for the dog signs.

From East El Paso:

Take Loop 375 to McCombs. Exit McCombs and turn toward Chaparral and stay on McCombs until it deadends into Lisa. Turn left. Go to DeLara Estates Drive (across from the Sheriff's office) and turn left. Come down until it turns to dirt road and take the first real left after that onto County Road A074. Come down past the stop sign in the middle of the road staying to the right House on the left – look for the dog signs.
