All dogs will be competing for obedience titles through ASCA. Each entry form must have a current registration number (ASCA or recognized registry) and be completely filled out, no exceptions. If your dog has earned titles through any other registry, but not ASCA, your dog will be required to begin in Novice. **Attention Obedience and Rally Exhibitors!** ASCA implemented a new policy as of 1/1/04 stating that every non-ASCA registered dog must acquire a 'tracking' number if you wish to compete. This is a one-time fee of \$10 per dog and a one-time \$10 ASCA service membership to establish the tracking number. You will be able to apply for a tracking number the day of the trial, if your dog does not have one. For more information, please visit the ASCA website www.asca.org
