Non-Regular Junior Showmanship; Pee-Wee 3-5, Sub Juniors 6-7, Regular Junior Showmanship: 8-12 Novice, 8-12 Open, 13-17 Novice, 13-17 Open Non-Regular Conformation; 2-4 month puppy, 4-6 month puppy, divided by sex.

Regular Conformation; Altered followed by Intact; 6-9 month, 9-12 month, 12-15, 15-18 month, Novice, American Bred, Bred By Exhibitor, Open Blue Merle, Open Red Merle, Open Black, Open Red, Best of Breed

**Rosettes and Prizes offered: BJH, RJH, BOBP, BOSP, WD, RWD, WB, RWB, BOS, BOW, BOB (altered and intact) Obedience/Rally Awards/Ribbons:** 1st thru 4th place and green qualifying or X qualifying ribbons will be awarded when applicable. Rosettes will be given for HIT, High Combined, HIT Aussie, HIT Other Breed and HIT Junior Handler. Dogs must receive a qualifying score to receive a ribbon.

Bitches in season permitted. They must be crated at least 50' from obedience ring, wear pants, and run last after all obedience judging is finished. Bitches in season are allowed at all events and are eligible for awards, legs and scores.

ASCA® Performance Titles. A Tracking number is required for obedience/rally competition. Rules and forms can be found at
