From I-5 North or South: Take the Woodburn Exit 271, go East through Woodburn for 6 miles on Highway 214, turns into Highway 211. Turn right (south) on South Meridian Road, follow 2 miles and the venue, Wooden Shoe Tulip Farm is on the left.
