NOTE TO OBEDIENCE COMPETITORS: THIS IS NOT A MATCH. All dogs will be competing for obedience titles through ASCA®. Each entry form must have a current registration number (ASCA® or recognized registry) and be completely filled out, no exceptions. If your dog has earned a title through any other registry, but not ASCA®, your dog will be required to begin in Novice.

Tracking Fees for Non-ASCA® Dogs: All non-ASCA® registered dogs will be required to have an ASCA® Tracking Number. This is a one-time fee of \$10.00 per dog. At the time of applying for the tracking number, the individual owner must also be an ASCA® member (Service member fee-\$10.00). ASCA® membership does not need to be maintained in subsequent years. You will be able to apply for a tracking number the day of the show, if your dog does not have one. ## **GENERAL SHOW AND SITE INFORMATION**

- Show Site is indoors with heat, and a thick matted floor.
- **The show building will open at 4:30 pm on Friday, September 17, 2021 and at 8:00 am on Saturday & Sunday, September 18 & 19, 2021 for ALL Exhibitors**
- If your equipment is inside the buildings prior to this time, IT WILL BE REMOVED.
- There is limited crate/grooming space & electric outlets in this building and it is in a separate area.
- **You will be asked to stack crates if necessary. Limited Groom Tables per exhibitor due to limited space.**
- NO X Pens Allowed; all crates/grooming tables must be on a protective mat
- **ABSOLUTELY NO CHALKING or BLOWING OUT of CHALK ALLOWED!!!**
- **NO GROOMING IN THE EXIBITION AREA**
- NO CRATING or seating allowed within 10 feet of the performance rings.
- There will be NO reserving or holding set up space at this facility.
- ALL exhibitors are required to keep their grooming & crating area clean!
- NO dogs are ALLOWED to be left in the show building unattended.
- **EXHIBITORS ARE REQUIRED TO CLEAN UP AFTER THEIR DOGS!**
- IF you do not you will be asked to leave with no REFUNDS!
- All dogs and equipment must be removed from the building within ONE HOUR after the conclusion of the show/rally trial on Sunday, September 19, 2021 or you will be charged the hourly rental rate of \$50.00 per hour for the building.
- **NO CAMPING or OVERNIGHT parking allowed at site!**

**From South I 94 – Exit 40** on to East US 20

**From North**– US 39; left on US 20, right on N175E, which changes to 150 E. site on left

**From East**– West US 20; left at stoplight at N450E, turn right on US 2, right on 150 E.

**From West** – From LaPorte, go East on US 2 turn left on 150 E; site is on right

**From South**– Take US 2 East through La Porte, left on 150 E; site is on right.
