There is no opening date for entries: you may enter now.

CLASSES OFFERED, RUN ORDER and ENTRY LIMITS:

Obedience: Utility B/A, Open ODX B/A, Open CDX B/A, Novice C/B/A (group exercise will follow completion of the Novice A individual exercises), Beginner Novice B/A

Rally: Masters C/B/A, Excellent C/B/A, Advanced C/B/A, Novice C/B/A

The entry limit is 60 runs per day

SITE INFORMATION:

The trials will be held at Thorson's Arena on Watsonville Ct, San Martin, CA. The ring is sited in a partially enclosed building on a packed dirt surface. Rally ring will be a minimum of 40' by 50'. The property will be open on trial day from approximately 6:00 am to 6:00 pm.

DIRECTIONS TO THE TRIAL SITE:

From the North or South: Take highway 101 to Tennant Ave in Morgan Hill. Exit freeway and head west (right if coming from San Jose) on Tennant Ave. At the traffic light—about ¼ mile past the freeway--turn left onto Butterfield Blvd. Butterfield Blvd becomes Watsonville Rd after crossing Monterey Rd. In another 2.5 miles turn left onto Watsonville Ct—and immediately enter the parking area.

SCHEDULE:

Morning trial: The morning trial will start at 8:00 am. Day-of-trial entries for both the morning and "afternoon" trials (if available) will be accepted only between 7:00-7:45 am.

"Afternoon" trial: The "afternoon" trial will start 30 minutes after the completion of the morning trial, but no earlier than 10:00. Move-ups will be accepted for only 15 minutes after the completion of the morning trial.

AWARDS:

Obedience: Obedience: 1st-4th place ribbons for each class; Qualifying ribbons for scores of 170 or higher; Rosettes for High in Trial in the regular classes, Highest Combined Score in Open B and Utility and Highest Scoring Junior Handler in the regular classes.

Rally: 1st-4th placement ribbons for each class. Qualifying ribbons for scores of 170 or higher: X-qualifying ribbons for scores of 195 or higher. Rosettes for High in Trial in the regular classes, Highest Combined Score in Masters B and Excellent B and Highest Scoring Junior Handler in the regular classes.

ENTRY INFORMATION:

Dogs must have an ASCA registration number, a LEP number or a QTracker number to participate in these trials. More information about and an application for a QTracker number is available at <https://www.asca.org/wp-content/uploads/2016/04/trackapp.pdf>.

No entry will be accepted from a dog or handler disqualified from ASCA Obedience/Rally or all ASCA programs; nor from a person not in good standing with ASCA.

Pre entries must be postmarked by Tuesday November 9, 2021 and received by 6:00 pm Tuesday November 16, 2021.

The daily entry limit for these trials is 60 runs. Once the daily entry limit is reached, the trials for that day will close. No pre entries nor day-of-trial entries will be accepted for trials that have closed. Neither will entry fees will be refunded for trials that have closed.

Pre entry fees: \$18 per class; \$12 discounted price for the second class that a dog is entered in at any one trial. (Note: there are two trials each day. This discounted price is only available for dogs entered in two classes in the *same* trial.)

Day-of-trial entry fees (for entries NOT postmarked/received by the pre entry deadlines): \$25 per class. There is no discounted price for additional classes. *Please contact the trial secretary to verify day-of-trial availability.*

The entry forms were updated on **October 8, 2020**. Only these entry forms will be accepted.

Please clean up after your dog. Please keep your dog on leash when not competing.

COVID-19 CONSIDERATIONS:

Currently, The CDC has established that unvaccinated people should continue to wear masks in public while fully vaccinated people can safely go without them outside as long as they are not in a crowd. (This event is not considered a crowd.) If conditions deteriorate, we will require participants to follow all COVID-related regulations in effect at the time of the trials.

Do not come if you feel sick. Do not come if you are not comfortable being around others that are following state/local COVID guidelines.

Everyone is encouraged to maintain 6' social distancing. Avoid shaking hands or hugging. Avoid touching dogs that are not your responsibility.
