## Directions:

**From Reno:** 395 South to Hwy 88 (first  
signal as you come into Minden). Go right  
for about 5 miles. Watch for trial signs on  
right.

**From Sacramento (from hwy 88):** Left  
side of Hwy 88 about two miles North of the  
California/Nevada state line. Watch for trial  
signs on left.

**From So. California:** 395 North to first  
signal at South end of Gardnerville  
(Pinenut/Riverview). Go left past 7-11  
(Riverview). Stay to the right and continue  
through two stop signs. At third stop sign  
go right and continue to Highway 88. Go  
left on 88 and travel about 1.25 miles.  
Watch for trial signs on right.

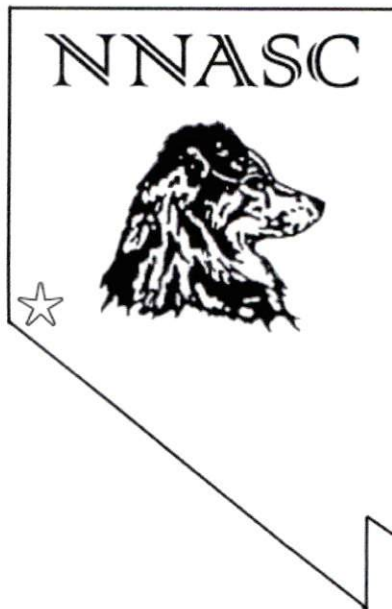
