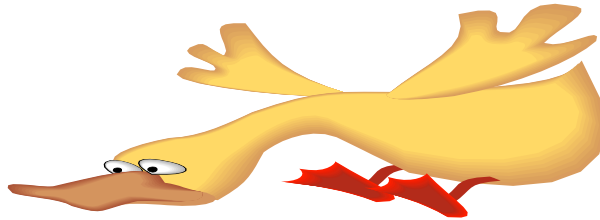

Entries Open December 20, 2021 – entries will be accepted by postmark, entries postmarked prior to 12-20-21 will not be accepted.....Pre-entry closes January 21, 2022.....Will accept DAY OF show entry if runs available

RUNS per day – 52 RUNS OF Sheep , 32 runs of Ducks

Course Director: Donna Fisher

Handlers meeting starts at 7:45 am and trial starts at 8:00am. Run order will be drawn prior to trial date. Handlers with multiple dogs will be separated as well as possible to allow time to exchange dogs between runs. There will be a set run order and dogs will be expected to run at their assigned time. If a handler has a conflict, they must notify the Course Director ahead of their assigned run time

- **AM DUCKS TO BEGIN 20 minutes after Sheep Trial begins**
- **PM TRIAL TO BEGIN 30 MINUTES FOLLOWING THE AM TRIAL**

Saturday: Sheep Course H clockwise -

Sunday Sheep will be course A counter clockwise / All weekend
DUCKS: course A counter clockwise 5 head/Ducks. 3-5 head/Sheep.
Divisions: Advanced, Open, Started, Novice Handler, FEO, Working Jr.

- Individuals will be responsible for any damage done to the stock and/or equipment. Ducks \$50.00 and Sheep \$350.00.

- Entries will not be refunded for any reason after pre-entries close (January 21, 2022).

-Substitutions of another dog you own will be allowed.

- Please notify the Course Director of move ups as soon as possible.

- Individuals are responsible for any damage done to or by himself, his family, his visitors and his dog, both on the premises and in the trial arena. ASCA, NHASC, & Rodney & Donna Fisher and Larry Fisher assume no responsibility for any accident or injury.

- All dogs MUST be on leash when not competing. This includes dogs that handlers don't think need leashes. Please clean up after your dog.

-All dogs must be crated away from the trialing arenas.

Directions: 15857 Hwy 105, Plantersville, Tx 77363

From Dallas: 45 South to the Conroe 105 exit- Go west towards Navasota....Just past the 1774 light in Plantersville (shell station) black pipe fence, the only house on the left.

From Houston: 45 North to the Conroe 105 exit, Go west towards Navasota....just past the 1774 light in Plantersville (shell station) Black pipe fence, house is on the left.

From Waco: take 6 south towards College Station. Navasota is approximately 20 miles. At Navasota you will take the Conroe 105 exit. Go east, approximately 14 miles to the 1774 light in Plantersville. Just past the light, black pipe fence, only house on the left.
