## Obedience Run Order

Open B (ODX/CDX), Open A (ODX/CDX), Novice C, Novice B, Novice A (Group exercises will follow A and B classes may be combined), Graduate Novice, Beginner Novice B, Beginner Novice A (optional titling class).

**Awards:** Ribbons 1<sup>st</sup>- 4<sup>th</sup> place, and green qualifying ribbon, rosettes will be given for High in Trial Aussie, High in Trial Other Breed, High Combined and High in trial Jr.

ASCA Performance Titles. A tracking number is required for rally/obedience competition. A dog will be allowed to be shown at a trial where the handler applies for an ASCA tracking number. No dog without an ASCA individual registration, LEP number or ASCA tracking number may compete in any ASCA Obedience trial.

Exit **HIGHWAY 18 EAST**  
Exit **AUBURN-BLACK DIAMOND ROAD EAST** keep right  
**RIGHT** at **SE GREEN VALLEY RD** (just past Neely Mansion)  
Follow Green Valley Rd **APPROXIMATELY 7.5 MILES**  
**RIGHT** onto **212th Way SE**  
First **LEFT** into Argus Ranch driveway Follow signs for parking

**FROM SR-169 SOUTHBOUND**

- **RIGHT** onto **ROBERTS DR** (in front of coal car)
- **Follow Roberts Dr APPROXIMATELY 4 MILES**
- **LEFT** at **218th ST**
- **Bottom of the hill is STOP SIGN**
- **STRAIGHT ACROSS OVER CEMENT BRIDGE**
- **First LEFT** into Argus Ranch driveway Follow signs for Parking

**FROM SR-169 NORTHBOUND**

- **LEFT** at **SE GREEN VALLEY RD** (Boondocks Nursery)
- **Follow Green Valley Rd (APPROXIMATELY 4 Miles)**
- **Left** at **212th Way SE**
- **First left** into Argus Ranch driveway
