**Directions:** From Red Lodge, MT: At the roundabout at the north end of Red Lodge, take the second exit onto US-212 and head north for 7.3 miles. Turn left into the Yellowstone Dog Sports driveway.

From Billings, MT: Merge onto I-90 West (toward Butte). Take Exit 434 (US-310/US-212). Turn left at the end of the off ramp for Exit 434 and head toward Red Lodge. In 37 miles, turn left into the Yellowstone Dog Sports driveway. Drive slowly for the length of the driveway.

**RV Parking:** There is a limited amount of dry camping space for RV's and it is on a first-come, first-served basis. Fees are \$10 per night to dry camp. For dry camping reservations, please contact Lisa at [lisa@yellowstonedogsports.com](mailto:lisa@yellowstonedogsports.com) .

**Ring surface and Setting up:** The ring will be indoors on artificial turf. The arena will not be available for set-up before 5:00 p.m. on Thursday, July 7, 2022. Dogs shall spend minimal time in the seating area, shall not interfere with traffic in the seating area, and shall not interfere with dog performance in the ring.

**Lodging and Food:** Please see Page 9 for a list of motels in the area.

Breakfast, lunch, and dinner will be available from Yellowstone Dog Sports each day of the trial. Food menus and prices will be posted each day.

**Volunteers:** All exhibitors are encouraged to work. Please complete the volunteer form so you can be assigned to a job of your choice.

An agility volunteer worker raffle will be set up with a table full of prizes. For every class you work at the agility trial, you will get a raffle ticket for the prize of your choice in the agility worker raffle. The more you work at the agility trial, the more tickets you'll earn and the better your chances of winning.

Please know the trial can't be held without your volunteering, thus we appreciate your help!

**Check in time:** Is 7:15 AM on each day. If you check in on Friday, you do not need to check in again on Saturday or Sunday. The judge's briefing will be at 7:45 AM with subsequent walk-thru immediately following. The trial will start **at 8:00 AM each day.**

**Move ups:** From Friday to Saturday and Saturday to Sunday will be allowed. Written move- up forms will be provided and all move- up requests must be received by the Trial Secretary within 30 minutes of the completion of Friday or Saturday's last class.

**Anticipated Run Order:** For each day of the trial the run order will be (subject to change),  
Friday and Sunday: Gamblers 1 (EON), Regular 1&2 (EEOONN), Gamblers 2 (EON), Jumpers 1&2 (EEOONN)  
Saturday: Jumpers 1&2 (EEOONN), Gamblers 1 (EON), Regular 1&2 (EEOONN), Gamblers 2 (EON)

**Ribbons:** First through 4th ribbons in all jump heights and levels will be awarded. As will qualifying ribbons for each qualifying run. The following High in Trial awards will be awarded at the end of the trial on Sunday afternoon: Novice, Open, and Elite from the Championship Division, Junior Handler, Veteran, Overall Championship and Overall ACE.

For anyone earning an ATCH at the trial, there will be an ATCH ribbon and bar. Please advise secretary prior to the trial if you might earn an ATCH.

**Agility obstacles:** Will include: Dog Walk (no slats), Teeter Totter (no slats), Winged Jumps, Non- Winged Jumps, 5' 0" A-Frame (no slats), Open Tunnels and Weave Poles (with 24" spacing). All contact obstacles have rubber surfaces. Electronic timers will be used.

The **ACE program Standard Division** allows dogs 18 months or older to jump one height lower than their standard height. The **ACE Senior Dog Division** allows dogs ages 7 and older to jump 4" lower than in the ACE Standard Division. Course times in the ACE program will be 10% greater than the **Championship Division** dogs in Regular and Jumpers. Gamblers time will be the same in both programs and based on the height of the jump. Each dog and handler team can only enter either the Championship or Ace program on any one day of a trial. **NOTICE TO EXHIBITORS:** This trial will be held under the current rules and regulations of ASCA. Exhibitors, through submission of entry, acknowledge that they are knowledgeable of ASCA rules and regulations, and agree to abide by all rules in effect at the time of this trial.

The Management will not be responsible for the loss or damage to any dog exhibited, or for possessions of any exhibitor whether the result of accident or any other cause. It is distinctly understood that every dog at this event is in the care and custody and control of his owner or handler during the entire time dog is on the premises.

<p>If your dog is an ASCA registered Australian Shepherd, fill in your dog's registration number where indicated on the entry form. If your dog is not an ASCA registered Australian Shepherd and you would like to earn ASCA titles, you will need to obtain an ASCA Q Tracking Number for your dog. Once you have an ASCA Q Tracking Number, use it as your dog's "ASCA Registration Number" on all entry forms. Dogs without registration numbers will not be tracked for titles by ASCA. You may enter the trial "For Exhibition Only" (FEO), but no ribbons or placements will be awarded for FEO. <p>The organizing committee may refuse any entry on the basis expressly provided through ASCA rules and regulations or guidelines established by ASCA Board of Directors. COVID protocols used for this set of trials will be determined by guidelines and recommendations that are in place at the time the trials are held. The Center for Disease Control, State of Montana, Carbon County, ASCA, Yellowstone Dog Sports resources as well as Beartooth ASC trial committee input will be used to develop the final requirements.

Specific COVID-19 protocols should be included in the exhibitor's final confirmation letter.

By entering these trials, you agree to accept and abide by any requirements in place during the agility trials.

- You **MUST** read and sign the new ASCA Legal Agreement on the Official Agility Entry Form.
- **PLEASE DO NOT FORGET YOUR FACE COVERINGS.** Disposable masks will be available at \$1.00 each.

Other requirements may include:

- Completed and signed facility and/or club waiver of liability.
- Acceptable face covering or mask that covers both nose and mouth mandatory when indoors or during certain activities (judges briefing, walking courses, etc.).
- Social distancing, masks required indoors when distance cannot be maintained with limited crating indoors.
- Limited persons in arena (judge, ring crew, competitors, observers at any one time).
- There may not be a leash runner due to covid restrictions; therefore, handlers can wear or pocket their leashes during their runs or toss them all the way to the exit side of the ring. The leash must be totally in the pocket or, if worn, ends must be secured.
- Briefings will take place so there is plenty of room for exhibitors to remain 6 feet apart.
- Course maps will be posted. Exhibitors are encouraged to take a picture of them with your phone or tablet. Please do not touch posted maps.
- Self-serve ribbons may not be permitted. **RIBBONS WILL NOT BE MAILED.**
- Scores will be posted. Please take a photo with your phone or tablet. Results will be emailed following the close of the trial.

## **TUNNELERS SHOOTOUT RULES**

**Eligibility and Entry Fees:** Any healthy dog over 18 months old will be able to enter. The entry fee will be \$10 per dog, and the payout for the winner in each Division will be half of the entry fees, based on the number of dogs entered in a Division. To enter, please include a note with your entry form and include the entry fee. We will also accept entries on the day of the Shootout.

**Divisions:** The divisions are Small (4-8-12") Medium (16") and Large (20-24-26"). Dogs will be in the division/height they would normally jump in the Championship program in ASCA agility (small dogs are dogs that measure less than 14" at the withers, medium dogs measure over 14" but under 18", and large dogs are all dogs that measure over 18").

**Tunnelers Shootout:** A non-regular game with the course consisting of tunnels only, 12-14 obstacles. There will be two rounds. All dogs will run round one with the top five dogs per Division advancing to the Final round. If there are five or less dogs in a Division, then all dogs in that Division will advance to the Final round for a maximum of 15 dogs in the Final round (5 small, 5 medium, and 5 large).

**Scoring:** Dogs will be scored time plus faults. All faults will be added to the time of the run for a total time. Off courses are 10 second faults and failure to perform an obstacle are 20 second faults. Elimination faults (dog fouling in the ring, training in the ring, etc.) will result in an elimination.

**Prizes:** In addition to bragging rights, the top finalist in each division, small, medium, and large, will split 50% of the entry fees, with the other 50% going to the host club. The actual payout for winners will be based on the number of dogs entered in each Division. For example, if there are 20 dogs in the large dog Division, the entry fees would be \$200 for that Division, the club would keep \$100 of the entry fees, and the winner for that Division would get \$100. If there 5 dogs in a Division then the entry fees for that Division would be \$50, the club would keep \$25, and the winner of that Division would get \$25.

**AGREEMENT**

**IMPORTANT LEGAL AGREEMENT**—Please read the following carefully as it, among other things, may prevent you from suing ASCA® and persons/entities affiliated with it. This agreement could even require you to defend them from demands and suits by third parties that include an assertion of wrongdoing by you. (1) The person signing this Agreement represents being authorized to enter into it on behalf of him/herself, as well as (if different) the owner(s)/exhibitor(s)/handler(s) of the dog(s) for which an entry form is being submitted (all these parties collectively referred to herein as “Applicant”). (2) “Releasees” here collectively refers to the Australian Shepherd Club of America® (ASCA®); its affiliate clubs; and the officers and board of directors, staff, contractors, insurers, attorneys, and agents of ASCA® and of those clubs. (3) This Agreement voluntarily is entered into by Applicant in exchange for the acceptance of the associated entry form and permission to participate in related activities. (4) Applicant agrees to abide by the rules and regulations of ASCA® and any other rules and regulations applicable to this event. (5) Applicant certifies that the entered dog will not pose a hazard to people, property, stock animals, or other dogs, and further that the dog is current with rabies shots along with any other vaccinations required by its state of residence. (6) Applicant acknowledges and assumes the risks to Applicant and Applicant’s dog associated with participation in the event, among which could be ones associated with poor condition of the facilities and surrounding areas; security measures or lack of them; electrical appliances; fittings; show rings; the presence of unfamiliar persons; and the presence/involvement of other animals—whether stock, dogs, or otherwise. (7) Applicant further agrees to comply with all recommended and required health and safety precautions, among which may be those related to social distancing; quarantining; wearing of face coverings; and non-participation of persons exhibiting symptoms or for whom there otherwise has been a likelihood of recent exposure to COVID-19 or other contagious diseases. (8) Applicant additionally acknowledges and agrees to assume the risks associated with taking part in the event though others might neglect compliance with health and safety precautions/requirements or pose an undue risk of spreading disease. For example, as is true as to any public event, there is some risk that Applicant and/or those affiliated with Applicant may catch COVID-19 or another contagious disease at the event. (9) To the maximum extent permissible, this release is to be interpreted under Texas law, without application of its choice of law rules. (10) To the extent that Applicant—or another party suing on behalf of Applicant, or suing to recover based on injuries/death/damage to Applicant/Applicant’s dog/Applicant’s property—sues ASCA® (or a board member or staff member or agent of ASCA®) as a defendant, the sole appropriate forum (to the maximum extent permitted by law) for the suit shall be the state or federal courts serving Brazoria County, Texas (where ASCA® has its headquarters). (11) Applicant hereby releases and waives any claims Applicant otherwise might assert against the Releasees as to any injury or damage claim connected in any way to any alleged act or omission arising out of, or occurring concurrent with, the event and related activities, interactions, communications, and even adjacent premises. (12) This release is made not only as to Applicant but also for anyone who might assert a claim on behalf of Applicant or based on purported injury or damage to Applicant/Applicant’s dog/Applicant’s property, as well as any heir, beneficiary, assignee, executor, trustee, agent, or survivor of Applicant. (13) Applicant further agrees to assume sole responsibility for and indemnify and hold Releasees harmless from related claims, demands, judgments, and settlement payments. (14) These waiver, release, and indemnification provisions extend even to claims or demands asserting that the acts or omissions resulted in bodily injury or death or from intentional wrongdoing, as well as to attorney fees and other costs of defense. (15) The duties of indemnification further extend to any claims or demands asserted against Releasees that are alleged to have arisen out of the acts or omissions of Applicant, Applicant’s dog, or others affiliated with Applicant. Among other things, this means that Applicant would pay the legal defense of Releasees if someone sued them based on a claim Applicant carelessly exposed the claimant to COVID-19. (16) Applicant’s promises in this agreement apply without regard to the type of claim or cause of action asserted against Releasees. (17) To the extent any provision of this agreement is unenforceable, the remainder of it nonetheless is to be enforced. (18) This agreement is to be interpreted to provide Releasees with the maximum permissible legal protection from—among other things—claims and suits pursued by Applicant (and/or those acting on behalf of Applicant or over injury/damage to Applicant), as well as from ones based on the purported wrongful acts or omissions of Applicant. (19) Nothing in this Agreement requires you to indemnify Releasees from claims by third parties that involve no allegations of improper acts or omissions by you, those affiliated with you, nor your dog(s). (20) Applicant acknowledges having read, understood, and had the opportunity for independent legal review of this document prior to signing it.
