Both Rally Trials are Limited to 30 Entries per Trial

(Any entry received after trial fills will be contacted and asked to be on a wait list or have entry refunded at that time.)

Rally Class entry is open to all Australian Shepherds that have a permanent individual registration or LEP Number and are over 6 months of age or older, or any dog over 6 months of age or older that has a tracking number issued by ASCA or a tracking number application completed, and all fees paid on day of Trial.

YOU MUST SHOW PROOF OF YOUR ASCA® REGISTRATION OR TRACKING NUMBER/TRACKING NUMBER APPLICATION IF REQUESTED.

All Rally Entries must be on an official ASCA Rally Entry Forms!

GENERAL SHOW AND SITE INFORMATION

- Show Site is indoors climate controlled, with a thick matted floor.
- **The building will open at 8:00 am; Saturday, April 9, 2022 for ALL Exhibitors** (setup crew exception)
- If your equipment is inside the building prior to this time, IT WILL BE REMOVED. (setup crew exception)
- There is limited crate space; you may have to show out of your car.
- NO X Pens Allowed; all crates must be on a protective mat
- NO CRATING or seating allowed within 10 feet of the rally rings.
- There will be NO reserving or holding set up space at this facility.
- ALL exhibitors are required to keep their crating area clean!
- NO dogs are ALLOWED to be left in the building unattended.
- EXHIBITORS ARE REQUIRED TO CLEAN UP AFTER THEIR DOGS!
- IF you do not you will be asked to leave with no REFUNDS!
- All dogs and equipment must be removed from the building within ONE HOUR after the conclusion of the 2nd rally trial or you will be charged the hourly rental rate of \$50.00 per hour for the building.
- **NO CAMPING or OVERNIGHT parking allowed at site!**

From North 131 – Exit 38A; right onto West Main; Left onto 9th Street; Right on KL Ave; Left on 8th Street; facility on the right.

From South 131 – Exit 36 A; left two lanes go West onto Stadium Drive; right onto 8th Street; facility on the right just before KL Ave.

From East– Stadium Drive; right onto 8th Street; facility on the right just before KL Ave.

From West – Red Arrow Hwy/Stadium Drive; Left onto 8th Street; facility on the right just before KL Ave.
