- Rosettes and prizes will be given for Best Junior, Reserve Junior, Best of Breed Puppy, Best Opposite Sex Puppy, Best Veteran, Best of Opposite Sex Veteran, Altered & Intact Winners Dog/Bitch, Altered & Intact Reserve Winners Dog/Bitch, Altered & Intact Best of Breed, Best of Opposite Sex, and Best of Winners. There will be 5 Altered Premiers and 10 Intact Premier rosettes per sex. Rosettes and prizes will be given for class placements 1-4.

- Limited, temporary ring-side crating will be available, but NO grooming or grooming tables will be allowed in the Exhibit Hall, and crates must be removed at the end of the day.

Entry Information

- Entries postmarked before the opening date, July 1, 2022, or postmarked after the pre-entry closing date, Sept 30, 2022, will not be accepted and will be returned unopened.
- Entry fees will be refunded ONLY if written notice of cancellation is received prior to October 29.
- Returned checks do not constitute a valid entry. There is a \$35 service charge for returned checks.
- All dogs' ages will be calculated by their age on October 29, 2022.
- Do not send copies of registration papers with entries, but be prepared to present papers on all dogs six months of age or older.
- Exhibitors, through submission of entry, acknowledge that they are knowledgeable of ASCA rules and regulations.
- No entry shall be accepted which specifies any conditions as to its acceptance.
- No entry shall be accepted from a dog or handler disqualified from the ASCA Conformation program, a dog or handler disqualified from all ASCA programs, or a person not in good standing with ASCA.
