All entries must be on a current ASCA entry form. Please fill out a separate entry for juniors and conformation classes. Any dog over 6 months must have a permanent ASCA number.



This show will be held under the current rules and regulations of ASCA.

No entry shall be accepted from a dog or handler disqualified from the ASCA conformation program; a dog or handler disqualified from all ASCA programs: or a person not in good standing with ASCA.

Classes offered and sequence of judging:

Jr. Handling: Pee-Wee 3-5, Sub Jr 6-7, 8-12 Novice, 8-12 Open, 13-17 Novice, 13-17 Open, RJH, BJH

Non-Regular Classes (Divided by Sex): 2-4 Month Puppy, 4-6 Puppy, BOS Puppy, BOB Puppy

Regular Altered & Intact (Divided by Sex): 6-9, 9-12, 12-15, 15-18, Novice, Am. Bred, Bred-By, Open (Divided by Color), Winners Dog, Winners Bitch, Best of Winners, Best of Opposite, Best of Breed

Judging will start at 9 am each day, each following show will start no sooner than 15 minutes after conclusion of the previous show.

Awards: Ribbons 1st – 4th Place, Rosettes, awards all shows.

Facility and Grooming Accommodations: The show will be held outdoors on grass under a tent (no electricity available). Exhibitors may groom under the tent or work out of their vehicle. The grounds will open at 7:30 AM for setup. There is food on site, a dairy bar with sandwiches, burgers, ice cream. We are all encouraged to give them a visit!
