## **Prizes and Awards**

**Ribbons** for Placings 1 -4 (blue, red, yellow and white), qualifying and non qualifying scores count; Australian Shepherds and Other Breeds not separated. Qualifying scores ribbons (green).

**Rosettes** for the following:

- High In Trial Started
- High In Trial Open
- High In Trial Advanced
- High In Trial Compined

These prizes are given out each trial day. FEO runs do not count.  
The rules for calculating the prizes are available through your course director.

## **Other Information**

FINASC reserves the right to amend, correct and/or change any information contained herein due to any errors or unforeseen circumstances including but not limited to the amount of entries received necessitating judge and/or schedule changes.

Please follow all our instructions and keep your dog/s under control.

All dogs that come to this event have to have a valid rabies vaccination. This is also valid for dogs not competing at the trial. Please take your vaccination certificate with you, we may check it. If it is found that the dog is not vaccinated sufficiently, this dog will be disqualified.

Please keep your dog/s on leash when not trialing.

The owner of a dog is liable for all damage his/her dog causes to the facility, other dogs or livestock and persons.

PLEASE: when you leave the place make sure you take all your garbage with you, also the left overs of your dog/s!!

#### 1-high way from South

Drive from Helsinki to north about 40 km, take junction 25 to Turuntie (110), drive about 15 km and turn right to Somerontie (280), drive about 44 km and turn left to Härkäläntie, drive about 1,9 km and turn right to Saarentaantie, drive about 1,7 km and turn left to Metsänojantie.

#### 1-high way from North

Drive from Turku to south about 50 km, turn left to Somerontie (52), drive about 28 km and turn left to Vakkurintie, drive about 2,2 km and turn right to Saarentaantie, drive about 1,7 km and turn left to Metsänojantie.
