All entries must be on a current ASCA entry form. Please fill out a separate entry for juniors and conformation classes.
Any dog over 6 months must have a permanent ASCA number.

This show will be held under the current rules and regulations of ASCA.

No entry shall be accepted from a dog or handler disqualified from the ASCA conformation, obedience, and/or rally program; a dog or handler disqualified from all ASCA programs: or a person not in good standing with ASCA.

Classes offered and sequence of judging:

Sweepstakes (Between Friday AM and PM Shows Only) (Divided by Sex): 2-4, 4-6, 6-12, 12-15, 15-18, 18-24.

Jr. Handling: Pee-Wee 3-5, Sub Jr 6-7, 8-12 Novice, 8-12 Open, 13-17 Novice, 13-17 Open, BJH

Non-Regular Classes (Divided by Sex): 2-4 Month Puppy, 4-6 Puppy, BOB Puppy

Regular Altered & Intact (Divided by Sex): 6-9, 9-12, 12-15, 15-18, Novice, Am. Bred, Bred-By, Open (Divided by Color), Winners Dog, Winners Bitch, Best of Breed

Awards: Ribbons 1st – 4th Place; Ribbons for all winners all shows, all days.

Rally classes offered to be run in the order listed: Masters C/B/A, Excellent C/B/A, Advanced C/B/A, Novice C/B/A. Q and QX ribbons. 1st - 4th placement ribbons. Ribbons for High Combined, High in Trial and High in Trial Junior.

Obedience classes offered to be run in the order listed: Utility B/A, Open CDX B/A, Open ODX B/A, Novice C/B/A (Novice Sits & Downs to be held prior to the individual exercises), Beginner Novice B/A. Q ribbons. 1st – 4th placement ribbons. Ribbons for High Combined, High in Trial and High Scoring Junior.

Bitches in season will not be allowed to compete in Rally and Obedience.

Conflicts: If you have a conflict with events, conformation takes priority. Notify ring stewards 30 minutes before the ring starts to get scheduling worked out. We will try to be accommodating, but we must know you have a conflict. If you do not make it to do your run by 5 minutes after the completion of the class, we will not look for you, and you will forfeit your run.

Directions: Take exit 434 for US-212/US 310 towards Laurel/Red Lodge, turn left onto US-212 W/US-310 E, arrive at facility.

Facility Hours: 7:00am – 10:00pm

Facility Accommodations: Events will be held outside on grass.

Food: Snack Bar on site. Restaurants and other food options in Roberts (5 miles away) and Red Lodge (8 miles away).

Grooming Information: Set ups are allowed near ringside. No electricity available, generators allowed on gravel surfaces only.

Grooming Clinic:

Jewel Fuls will conduct a grooming clinic from basic maintenance to show grooming. Friday at 7:00pm after the PM shows. Cost \$10 for adults, free for Juniors. Sign-ups will be taken at the conformation table.
