Entries open not earlier than 2nd June, 2022 and close 28th June, 2022 (postmarked). Entries sent via Email will NOT be accepted!

Day of show entering will be possible if available.

Entries day of show (if available):

Friday 11.30 – 12.30 AM

Sat. 8.00 – 8.30 AM

Sun. 8.00 – 8.30 AM

No entries will be accepted after close of entries. You have to pay cash for your entries when entering day of show.

The catalogue will be available through a QR Code. There will be also a few printed examples available at the ground for 5 EUR/each. Please let us know with your entries if you will purchase a printed version. The catalogue will then be reserved for you.

Class Order for ALL Shows

Non-Regular Conformation: 2-4 mo., 4-6 mo., BOBP, BOSP, Veterans 7-10, Veterans 10+ years old. Classes will be divided by sex and age, Best of Breed Veteran, Best Opposite Sex Veteran.

Junior Showmanship: 3-5 Pee Wee (adult must accompany the child, each child will be going separately in the Ring), 6-7 Sub Jr, Novice and Open 8-12 and 13-17.

Altered then Intact Conformation: 6-9, 9-12, 12-15, 15-18, Novice, German Bred, BBX, Open Blue Merle, Open Red Merle, Open Black, Open Red. Classes divided by sex. Class winners to compete for Winners dog or Winners bitch. Winners dog and Winners bitch will compete with specials for BOB, BOS, and BOW.

Ribbons: 1st through 4th place

Rosettes: BJH, RJH, BOBP, BOSP, Best of Breed Veteran, Best Opposite Sex Veteran, Altered and Intact WD, RWD, WB, RWB, BOB, BOS, BOW.

Refund of Pre-entries & Class Changes

Pre-entries will be refunded only upon written request received prior to close of pre-entries. No other entry refunds will be granted. In case of illness of dog or handler the entry fees will be reimbursed if a certificate by the vet or doctor is given to the trial secretary.

No class changes will be made once pre-entries have closed.

All current ASCA rules and regulations apply. No entry shall be accepted from a dog or handler disqualified from the ASCA Conformation program; a dog or handler disqualified from All ASCA programs; or a person not in good standing with ASCA. All dogs 6 months of age and over must have individual registrations to compete in all ASCA sanctioned events. Jr. Handlers must enter all required information. All entries must be on the new official ASCA entry forms with the agreement/disclaimer & signature on back. Incorrect and or missing information will invalidate entries.

Vaccinations:

You must show proof that your dog is current on its rabies vaccinations. Other vaccinations may be recommended. Be prepared to show your vaccination passports to veterinary officials of the city/county to be allowed on the show grounds. For further information please check

Tail status/Docking ban

Germany has a docking ban and no docked dogs may be exhibited without an appropriate medical reason by a vet. You MUST attach a certificate from the vet to your entry if your dog is docked due to medical reason to be

allowed to compete in the conformation shows. You also **MUST quote the tail status** of your dog on the accompanying ASCA registration certificate if this status is not already quoted by ASCA.

Grounds and general information:

Grounds will be open all days from 8 AM and until 30 minutes after show is finished.

There will be enough parking space on the show grounds.

The Show grounds are in the middle of a residential area. **Please do not park your cars on the surrounding streets!** This will help us with the neighbors. It will also prevent you from receiving tickets.

Grooming will be possible around the show ring but no electricity.
