## **GENERAL ENTRY & TRIAL INFORMATION**

***SCANDWASC assume no responsibility for any loss, damage, or injury sustained by an exhibitor, handler, dog, property, child, or spectator. All attendance is at your own risk and you are responsible for any damage you or your dog inflict to other animals, person or property.***

Replacement fee sheep: 3000kr

Replacement fee duck: 500kr

Arena size (sheep): 40 x 70m

Arena size (duck): 20 x 30m

Classes available: Started, Open, Advanced

Bitches in season: Bitches in season will run in draw order. When not competing, they should remain crated and kept away from other dogs.

Running order: Will be drawn and posted prior to start.



# Stockdog Trial

- All dogs must be on leash or crated when not competing.
- Changes and/or substitutions must be submitted to the trial secretary in writing the evening before the trial.
- Move-ups are allowed, but they may not be recorded correctly unless written notification is provided to the trial secretary prior to the start of the trial.
- Any change requests, including substitutions, must be submitted to the trial secretary in writing the evening before the trial.

## **Entry fees will be refunded:**

- When a dog has been certified by a licensed veterinarian as unable to compete due to sickness or injury. Owner will be responsible for all vet fees.
- When the trial has to be cancelled due to the COVID 19 virus
- Run limits and judging assignments are subject to change.
- Selling runs will not be permitted. If the trial is full and you wish to sell a run, the transaction must be handled by the trial secretary, who can ask the course director to handle it. All offers to buy or sell runs must be submitted in writing.

## **Please clean up after your dogs.**

This trial is being held on private property.

You acknowledge by your attendance and/or entry that the Show/Trial Committee and Hosts have the right to refuse or excuse any entry or spectator for good cause.

Good cause would be violation of the private property owners' rights or violation of the ASCA show rules. For the safety of your dogs and others all dogs must have current vaccinations.

Dogs are not allowed to be let of leash anywhere. Please consider the wildlife, farmers' fields, and other stock.

## **Stock dog awards:**

- Ribbons awarded for 1<sup>st</sup> - 4<sup>th</sup> place. Qualifying ribbons for qualifying scores.
- Ribbons for High in Trial and Most Promising started (judges' choice).

## **Data Protection**

Data Protection: Due to the GDPR (General Data Protection Regulation), each SCANDWASC member and each trial participant must agree to the processing of his personal data. This approval is to be granted once and serves to ensure the fulfilment of the objectives of the SCANDWASC. The completed (pdf with text entry) and signed statement is, if not yet submitted in a previous trial, to be added to the trial entry.
