The trial will be held under the current rules and regulations of ASCA. Rally rules for ASCA can be found at: <https://asca.org/wp-content/uploads/2020/02/rallyrules.pdf>

ASCA Conformation will be held at this trial site Saturday and Sunday. We are starting with the Rally Trial 1 at 8AM, then Conformation at 12:00PM, Rally Trial 2 will begin at 2PM and the last Conformation Show will begin at 4PM on Saturday. If you are entering both, please write it on your entry so we can note it and put a "C" on the gate sheet. Conformation on Sunday will start at 9AM and the 2nd show will be 30 minutes after finishing the first show.

Directions to the show: From Houston take IH 45 to Conroe, take South Loop 336 go right, stay on 336 to Hwy 105. Turn right on Hwy 105, go approximately 12 miles to the light at North Walker Rd., go left at the light – trial site is 2 miles on left side after an open field.

SPEED LIMIT ON NORTH WALKER ROAD IS 35 MPH!!! HEAVILY PATROLLED!!!

Directions to the show: From the North take IH 45 south to Conroe. Take North Loop 336 exit and go over freeway staying on Loop 336 to Hwy 105. Turn left on Hwy 105, go approximately 12 miles to the light at North Walker Rd. Go left at the light – trial site is 2 miles on left side after an open field.

Rally Trials are open to all breeds, but you must have a tracking number from ASCA. Trial Schedule for Rally Trial 1: Saturday September 10, 2022 – 7:15AM – 7:30AM
Registration for day of show trial entries if available, move-ups & check in for all Rally exhibitors. Walk thru course begins at 7:35AM-7:55AM. Judging begins at 8:00AM. Classes will run from Masters C through Novice A.

Trial Schedule for Rally Trial 2: Saturday September 10, 2022 – 1:15PM – 1:45PM
Registration for day of show trial entries if available, move-ups & check-in for all Rally exhibitors. Walk thru course begins at 1:30PM-1:50PM. Judging begins at 2:00PM. Classes will run from Masters C through Novice A.

The show site will open Saturday & Sunday at 7:00AM. Friday, Sept. 9 show site will open at 12:00PM. If you prop doors open to unload, PLEASE close them ASAP when done. No dogs may be left at the show site overnight. Pre-entry Price: \$15.00 each class entered. Junior Entry Price: \$10.00

each class entered. Day of Trial Price (if available): \$20.00 for each class entered. Junior Entry Price: \$15.00 each class entered. If the trial fills, we will have a wait list. Limit of 30 dogs per show.

Awards: Rally, qualifying scores will receive a green ribbon; strip ribbons will be awarded for placements in each class. Rosettes will be awarded for High Scoring Australian Shepherd, High Scoring Other Breed, High in Trial Overall, High Combined, High in Trial Junior Handler. Rally Qualifying scores of 195 and higher will receive strip ribbons indicating an "X" qualifying score. New Title ribbons will be available for those finishing a Rally title.

Special Notices for Exhibitors: No training is allowed in the ring at these trials. No harsh training is allowed on the trial grounds at any time; this includes inside and outside the building. Please read the rules for the classes and events you are entered to make sure you have a full understanding of ASCA Rules and Regulations. **Bitches in season will not be permitted to show at these trials and are not allowed to be in the building or crated in the building.** All entries must be on official ASCA entry forms only, must be the updated form. No other forms can be accepted. All entries must be signed. Rally entry form can be found at: <https://www.asca.org/wp-content/uploads/2016/04/rallyentrywtx.pdf> Exhibitors, through submission of entry acknowledge that they are knowledgeable of ASCA rules and regulations. No entry shall be accepted which specifies any conditions as to its acceptance. All entries

must be accompanied by a check or money order for the appropriate amount or will not be considered a valid entry and not be accepted for entry. Entry forms will be available at the check in table for Day of Trial Entries, as well as tracking number forms if needed. No entry fees will be refunded after August 29, 2022. Make checks payable to LALD – ASC. Returned checks do not constitute a valid entry and will be subject to a \$35 charge and also reported to ASCA if restitution is not made in a very timely manner. All dogs must have an ASCA registration number or an ASCA tracking number to compete with the exception of those who submit their application for a tracking number at the trial desk. No entry will be accepted without a tracking number, registration number or a valid application with a check made payable to ASCA for a tracking number.

The State of Texas requires a current rabies vaccination. All dogs over 12 weeks of age must have a current rabies certificate. A tag does not show proof of vaccination. Thank you for your cooperation. NO dogs under 2 months of age will be permitted at this trial. Any handler, owner, or spectator using excessive abuse towards a dog or exhibiting poor sportsmanship will be asked to leave the Trial site for the duration of the Trial.

No entry will be accepted by persons or dogs not in good standing with ASCA. Grooming, crating, food and dog treats must be kept at least 10 feet from the ring. LALD – ASC, their Board of Directors, ASCA, its Board of Directors, and the property owner assume NO RESPONSIBILITY for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs, personal property and/or children. Young children must be supervised.

PLEASE CLEAN UP AFTER YOUR DOGS at the show site and at the hotels so we can continue to have this site and the area hotels available for our use for dog events! We appreciate your assistance in this matter as always!
