Obedience #1- 8:30 a.m.

Obedience #2- 10:30 a.m. or 20 minutes after end of 1<sup>st</sup> trial

**Rally Classes offered:** Masters A,B,C/Excellent A,B,C/Advanced A,B,C/ Novice A,B,C

**Obedience classes offered:** Utility A & B, ODX A & B, CDX A & B, Novice A, B, & C, Beginners Novice A & B

\*\*Group Exercises will be held at beginning of trials, prior to individual runs

#### **Pre-Entries must be postmarked Sept. 17, 2022**

ENTRY FEES:

Pre-Entry Fees: \$20.00 Regular classes (Rally & Obedience)/ Day-of-trial: \$25.00 Regular Classes

Pre-Entry Fee \$10.00 2<sup>nd</sup> entry of same dog in same trial / Day-of-trial \$15.00 2<sup>nd</sup> entry of same dog in trial

Junior Handlers: \$10.00 per class Pre-Entry/ \$15.00 Day of Entry

**Make checks payable Amigos ASC. (Returned check fee of \$25 will be charged if the payment is reversed or declined.)**

Day of trial entries will be taken 7:30- 8:15 a.m. on each morning. Armbands can be picked up during this same time.

**\*\*Rally trials will be limited to 40 runs each and obedience trials will be limited to 30 runs each. In the event the trial fills then you will be put on a waiting list according to the postmark date on your entry. We will contact you via email if a space becomes available.**

Entries must be made on the current ASCA Rally and obedience Entry forms which can be found at

funds only. No entries will be accepted that require a signature or require a trip to the post office. If you use overnight mail, you must waive signature.

**SITE CHANGE-**The trial will be held indoors on matted floor in 40' x 50' ring at a dog training facility. There is limited space. No X-pens please. There are many crates inside the facility that are available to use for your dogs. Bring your own crate pad and water bucket. There are chairs available in the facility also but you may want to bring your own chair if there is not enough seating. This is an ASCA sanctioned event and will be governed by the rules of the Australian Shepherd Club of America.

### **Ribbons & Awards**

Qualifying ribbons will be awarded for all qualifying scores of 170-194.

X-Qualifying ribbons will be awarded for all qualifying scores of 195-200.

Flat strip ribbons will be awarded to 1<sup>st</sup> through 4<sup>th</sup> class placements,

2 layer strip ribbons will be awarded for High-In-Trial and High-Combined

Bitches in season are not allowed to compete at this trial.

Lunch and breaks will be taken at judge's discretion. There are fast food restaurants within .5 mile of site.

**Cancellation Policy:** No refunds will not be given but exhibitor may have credit to use at the next AASC event. Entry fees will not be refunded in the event a dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by action of the Show Committee. If, because of riots, civil disturbances, or other acts beyond the control of management, it is impossible to open or complete the trial, no refund of entry fees will be made.

No entry shall be accepted from:

- 1) a dog or handler disqualified from the ASCA Rally program
- 2) a dog or handler disqualified from all ASCA programs
- 3) a person not in good standing with ASCA

**Directions to trial site:** From Big-I, take I-25 south to Rio Bravo Blvd Exit. Head west on Rio Bravo Blvd. to Isleta Blvd Intersection. Then go south on Isleta Blvd to 1<sup>st</sup> street on left (eastside of road) which is La Mora. Turn left and the training facility is on the right after the Burger King. Please park inside gated parking lot not along road.

The building will be accessible 7:30am-2:30pm
