RALLY Classes offered: Starting with Masters: Masters, Excellent, Advanced, Novice
Levels A, B, C

First trial starts 9 AM

Second trial starts at 11 AM or ½ hour after the first Rally trial ends, if it runs later than 11

Third trial starts at 1 PM or ½ hour after the second Rally trials ends, if it runs later than 1

***A 30 minute lunch break may be taken at the discretion of the Judge

Pre-entries: Open 8/5/22, close 10/7/22, or when limits have been met

If limits are met "day-of" entries will not be accepted and a wait list will be maintained

No refunds after closing date

\$23 for Rally classes

Pre-entry Special – For the same dog: \$45 for two pre-entries, \$21 each additional pre-entry

Day of Show entries: (if limits have not been met) \$25 per entry for Rally. Trial 1 entries taken 8-8:30am, Trial 2 entries taken from 8-10:30 and Trial 3 entries taken 8:00am – 12:30 PM

This will be held in the red barn: covered, with dirt floor. Prizes include placement ribbons.

This is an ASCA sanctioned show, no food or corrections allowed.

Bitches in Season are not allowed to compete.

A food truck will be on site from approximately 7:30 AM to 2 PM

The trial will be held according to COVID guidelines on that day. Checks will be shredded if the trial is canceled.

These trials will be held under the current rules & regulations of ASCA. No entries will be accepted from a dog or handler disqualified from all ASCA programs, or a person not in good standing with ASCA. All Australian Shepherds over the age of 6 months must be registered. All dogs must have individual ASCA registration and rabies certificate available.

Effective January 1, 2004: All dogs six (6) months and older must have an individual ASCA registration or LEP number or and ASCA tracking number to compete in ASCA sanctioned Rally Trials. A dog will be allowed to be shown at the trial where the handler applies for an ASCA tracking number. The handler will be issued a receipt by the Registration table valid for sixty (60) days to allow the Business Office time to issue the tracking number. Photo copies or originals of registration or tracking number papers must be presented to the Registration Table upon request when entering ASCA sanctioned Rally Trials.

- The Novice A classes are for a handler who has not placed an Obedience or Rally title on a dog from ASCA or any other registry and the dog does not have an Obedience or Rally title from any registry
- All dogs competing for ASCA titles are required to start at Novice level and work through Masters regardless of titles awarded by other registries

Directions to Westfield Fairgrounds:

From Interstate 91: Take Exit 15, Holyoke Mall at Ingleside. Turn left at bottom of ramp. Go to second set of lights and turn right onto Homestead Ave. At next light turn left onto Rt. 202. Go approximately 5 miles. Cross Rt. 10 (at light) and go to cemetery on the left. At stop sign turn left. Show site is on the left, about 1 1/2 miles.

From the Massachusetts Turnpike—I-90: Take exit 3. Turn right at the light at the end of the ramp. Go about 100 ft. and make a right onto Arch Road. (Westfield Motor Inn/Westfield Econo Lodge is on the corner.) Go about 1.5 miles. the Southern States Building on your right. , make a left onto Cabot Road. Go to the end of Cabot and make a right onto Russellville Rd. Show site is a short distance up on the right.
