Tracking Fee for Non-ASCA Dogs: All non-ASCA registered dogs will be required to have an ASCA QT Tracker Number. This is a one-time fee of \$20.00 per dog. At the time of applying for the tracking number, the individual owner must also be an ASCA member (Service member fee \$20:00). ASCA membership does not need to be maintained in subsequent years. You will be able to apply for a tracking number the day of the show, if your dog does not have one. If your dog has not earned any ASCA titles, your dog is required to begin in Novice. ASCA title requires 3 qualifying scores under 2 judges.

No entry shall be accepted from a dog or handler

disqualified from the ASCA conformation program; a dog or handler disqualified from all ASCA programs; or a person

not in good standing with ASCA.

All Aussies over six (6) months of age may be asked to show

proof of ASCA registration. Be prepared to present

registration papers on all dogs six (6) months of age or older as of the date of the show.

All dogs may be asked to show proof of rabies vaccination.

In that event, a certificate from a licensed veterinarian is

required. Pursuant to ASCA rules, any dog displaying clinical

symptoms of a communicable disease will be removed from the trial site, with no refund of entries. In the case of removal

of a dog that shows symptoms of any contagious disease, all

dogs in the same household or traveling with said dog shall also be removed

from show site. (Also per RRVASC policy). No refunds. Any

dog that displays viciousness toward people or animals at any time on the show premises will be ejected from the show site

for the entire show weekend with no refund of entries. There

will be no refunds in the event that a dog and or handler are dismissed from the competition, regardless of the reason.

Physical abuse of any animal will not be tolerated. Any person on the show site reported to have physically abused

an animal will be ejected from the show site for the entire

Please stack crates wherever possible.

Do not leave unattended dogs on grooming tables.

Building will open at 7:30 AM each day and will

close one hour after conclusion of show
