Refund of Pre-entries & Class Changes– Pre-entries will be refunded only upon written request received prior to close of pre-entries. No other entry refunds will be granted. No class changes will be made once entries have closed.

Returned Checks: Any check returned to our bank will invalidate all entries associated with that check. In addition, the person writing the check will be reported to ASCA – No Exceptions. Delta ASF will add a \$35.00 Collection fee to the amount of each returned check. Anyone with a check returned must pay all future Delta ASF event fees in cash.
