Rally: Rally Trials will close with 25 runs for each trial. If trial fills, a waitlist will be started. Day of Trial entries will be accepted IF space is available. Move-ups will be allowed between trials. Entries must be postmark no earlier than November 15, 2022 for Aussies Only! All breed - Entries must be postmark no earlier than December 15, 2022. All must be postmark no later than Jan 16, 2023. Facility will open at noon for set up, close 30 minutes after the trial ends. All dogs must have an ASCA registration number or an ASCA tracking number to compete, except those who submit their application for a tracking number with their entry. No entry will be accepted without a tracking number, registration number or a valid application with a check made payable to ASCA for a tracking number. Rally Classes offered:

Masters C/B/A, Excellent C/B/A, Advanced C/B/A, Novice C/B/A. Awards: Qualifying scores will receive a green ribbon; X- Qualifying scores will receive a dark green ribbon; strip ribbons will be awarded for placements in each class. Rosettes will be awarded for High Scoring Australian Shepherd, High Scoring Other Breed, High in Trial Overall, High Combined, High Scoring Junior Handler. New Title ribbons will be available for those finishing a title.

Conformation Classes offered:

Junior Showmanship: Non-Regular: Peewee (3-5), Sub Junior (6-7) Regular: Novice & Open Junior (8-12), and Novice & Open Senior(13-17)

Non Regular: **Puppy** - 2-4 and 4-6 month puppies **Veteran** – 7-10, 10-12, 13+ All Non regular divided by sex.

Altered/Intact Regular: 6-9 month, 9-12 month, 12-15 month, 15-18 month, Novice, American Bred, Bred by Exhibitor, Open Blue Merle, Open Red Merle, Open Black, Open Red, and Best of Breed. Rosettes and prizes for BOB, BOS, BOW, Winners, Reserve Winners, BJH, RBJH, BOBP, BOSP. Strip ribbons otherwise.

Notice to exhibitors:

1. Entries on official CURRENT ASCA entry forms only. Copies may be made if signed statement is on the back. No other forms accepted. All entries must be signed on the back.
2. No entry fees will be refunded. Returned checks do not constitute a valid entry. There is a \$35 service charge for returned checks.
3. All dogs' ages will be calculated as of January 21, 2023. Be prepared to present papers on all dogs 6 months or older.
4. Grooming in designated areas only. No excessive grooming or bathing of dogs at hotels. PLEASE CLEAN UP AFTER YOUR DOGS.
5. Exhibitors, through submission of entry, acknowledge that they are knowledgeable of ASCA rules and regulations. No entry shall be accepted which specifies any conditions as to its acceptance.
6. The state of Texas requires a yearly rabies vaccination. All dogs over 12 weeks of age must have current rabies certificate. A tag does not show proof of vaccination. Thank you for your cooperation.
7. Dog sales are not permitted on the show grounds. No puppies fewer than 8 weeks of age allowed at the show site.
8. Any handler, owner, or spectator using excessive abuse towards a dog will be asked to leave the show site for the duration of the show weekend.
9. HOTASC, its Board of Directors, ASCA and its Board of Directors, and the property owner assume NO RESPONSIBILITY for any loss, damage, or injury sustained by exhibitors, handlers, or to any of their dogs, personal property, and/or children.
10. ASCA has the right to reprimand or suspend any person or persons from any or all privileges of ASCA for conduct

prejudicial to the best interests of the Australian Shepherd, ASCA events or ASCA. Exhibitors are to maintain the highest level of sportsmanship and are to conduct themselves accordingly. Foul or abusive language, yelling at exhibitors or judges, disorderly conduct, and/or poor sportsmanship will not be allowed and shall be disciplined in accordance with Chapter 11 and the ASCA Dispute Rules and ASCA Discipline Guidelines.

To be held under the current rules and regulations of ASCA. No entry shall be accepted from a dog or handler disqualified from the ASCA Conformation program: or a person not in good standing with ASCA
