2. Entry must be on CURRENT entry forms and must include both sides which can be found on the ASCA website (www.asca.org)

3. No entry shall be accepted if the dog or handler are not in good standing with the ASCA.
4. No entry will be accepted which specifies any conditions as to acceptance.
5. No entry fees will be refunded after the pre-entry deadline. Returned checks do not constitute a valid entry and will be subject to a \$35.00 charge and, also reported to ASCA if restitution is not made within 10 business days. 7. No refunds will be given for dogs absent, disqualified, excused, or barred from exhibiting by the show committee.
8. Owners are responsible for entering their dogs in classes in which they are eligible to compete.
