****JUMP HEIGHT CARD OR MEASUREMENT REQUIRED****

Dogs entering the standard jump height classes 20" or less (with height less than or equal to 20") that do not have a permanent ASCA, AKC or NADAC height card must be measured. Dogs entering 20+" or 24" jump heights are exempt. Please include a copy of your card with your entry or present your dog for measuring at check-in.

Notice that exhibitors, through submission of entries, acknowledge that they are knowledgeable of and agree to follow ASCA rules and regulations and ASCOT's trial policies, including but not limited to the following:

- This trial is open to all dogs, purebred or otherwise, at least 18 months of age.
- Bitches in heat, lame or blind dogs are ineligible for entry, as is any dog with a deformity which may cause the judge to not be able to reasonably assess the dog's ability to function and perform the obstacles safely, and in a manner that is in the best interest, health, and welfare of the dog. Any dog that demonstrates aggression towards any person or any other dog, whether inside or outside the ring, must be excused from the trial, as will any dog which the judge feels is not in enough control to perform all obstacles in a safe manner. Any owner, handler, or spectator exhibiting poor sportsmanship or abuse towards a dog or person will be required to leave the show site for the duration of the trial.
- Bitches in heat are not allowed on the trial site. Bitches that come into heat or dogs that become injured before the closing date may have their entry fees refunded, less \$25.00, pending proof by veterinarian. Refund to be made after the trial closing date. No other refunds will be made after trial closing date. Overpayments below \$10 will be returned only upon request otherwise such overpayments will go to Aussie Rescue.
- This show will be held under the current rules and regulations of ASCA. A copy of the rulebook may be obtained from the ASCA web site at www.asca.org.
- No leads, collars, food, toys, etc. shall be permitted on the course at any time.
- All dogs must be on leash or securely crated when not competing in the ring.
- Safety shall always be the foremost consideration in actions by handlers at all times.
- The organizing committee may refuse any entry on the basis expressly provided through ASCA rules and regulations. Anyone not currently in good standing with ASCA will not be allowed entry into the trial.
- Participation is a privilege afforded by the Host club(s) and may be extended or withdrawn by the Host club's trial committee based on suitable cause only. Refusal of entries shall be reported to the ASCA office.
- Entries must be made on the enclosed entry forms. Copies may be made if entire form is copied. No other forms will be accepted. Entries must be signed to be valid.
- Make all checks and money orders payable to **Australian Shepherd Club of Texas**. Returned checks do not constitute a valid entry and there will be a \$35.00 service fee on all returned checks. Entry into future trials and participation in this trial will not be allowed until all fees are paid in cash or money order. Illegible or incomplete entry forms do not constitute a valid entry.
- Dog sales or puppies under eight weeks old are not permitted on the trial site.
- ASCOT, their board of directors, ASCA, management, and the property owner assume no responsibility for any loss, damage, or injury sustained by the exhibitors, handlers, or to any of their dogs, personal property, and/or children.

Other Important Info

Catalogs/Run Orders - No catalogs will be printed. Running orders will be posted at the gates. Handlers with multiple dogs will be separated as much as the class allows.

Move-Ups - All move-up requests must be received by the trial secretary by **January 2, 2023**. There will be **NO move-ups offered on the weekend of the trial**.

Cancellation of Entries - Cancellation of entries due to exhibitor request prior to the trial closing date will be subject to a processing fee of \$25 per entry/dog at the discretion of the club. Refund of any entry fees following cancellation requests made after trial closing will be at the discretion of the club.

Obstacle Specification – The obstacles that will be made available to the judge of the trial are: Dog Walk, A-Frame (set at 5'6" for 12-24" jump height, 5' for 4-8" jump height by handler request), Teeter, Tunnel, Tire Jump (displaceable), Weave Poles (24" spacing), Non-Winged Single Hurdles, Winged Single Hurdles, and Double Bar Hurdle. All contacts have rubber surfaces. Dog Walk and A-Frame will be slatted.

Prizes and Awards - ASCOT will award strip ribbons for 1st through 4th places and awards for each qualifying score in the Titling Classes. Additional awards may be offered at club's discretion.

FEO (For Exhibition Only) – We will accept FEO entries. FEO entries may jump any jump height but will not be eligible for any prizes or awards. Minimum age permitted is 15 months. Any dog younger than 18 months must jump at a lower height than their regular jump height. This is a non-qualifying division.

Arena Note – Please note that the NorthCrest Equestrian Training Complex is a working rodeo and horse arena. Please expect smells, horses, and livestock associated with arenas. Any dog found harassing the livestock will be removed from the show site and no refunds will be made.

Parking – Please park on the crushed rock parking areas around the arena. If it has rained recently, please stay on the gravel to prevent getting your vehicle stuck in the mud. If you are crating out of your vehicle, you can park under the arena overhang on the West side of the arena, but please park your vehicle nose out and back up to just under the overhang. Do not block the alley between the area fence and the overhang as that is the only way for people to drive in/out.

Crating – You can crate in the arena around the rings, but please keep your setup at least 10' away from the rings.

Toys In The Ring – We will be permitting handlers to have toys in the ring at this trial. Toy runs will run **in order** in their jump height. For details, please refer to Section 9.1 of the most recent rulebook available at <http://www.asca.org>.

ACE Program

ASCA is offering an ACE Agility Program that permits any dog to jump 4" lower than their standard jump height and dogs 7 years or old to jump 8" lower than their standard jump height. For details, please refer to Chapter 4 of the most recent rulebook available at <http://www.asca.org>.

COVID-19 Information

1. Non-participants and the young, elderly, and anyone at risk are encouraged to remain at home.
2. Clubs, show officials, participants and anyone attending the show are required to follow state, local and facility guidelines that apply to the area and site where the event is held.
3. Do not attend if you are sick or have been in the last 5 days.
4. Do not attend if you have been near anyone with symptoms.
5. Social distancing is encouraged in crating areas, seating, restrooms, and anywhere else lines could be formed (Check-in, Course Map Postings, Results Postings, concession stand, etc.).
6. If you don't want volunteers to touch your leash, you may carry it in your pocket or fastened around your body during your run as long as it's not flopping around like a carried toy might. If your leash falls off or the dog grabs your leash during your run it will be considered a toy in the ring and scored as an elimination. ASCA and ASCOT assumes no liability if the handler chooses to carry their leash and it catches on obstacles and/or causes the handler to trip.
7. Participants are encouraged to use hand sanitizer.
8. Show officials and participants may be wearing face masks if government/facility regulations require it or if they choose to do so. You are strongly encouraged to accustom your dog to seeing people wearing facemasks prior to entering the trial.
9. Additional guidelines may be specified in your confirmation letter or at the event.
