SCHEDULE Conformation & Rally (both days): Friday: you may setup any time after 2 PM
 Saturday/Sunday: Please do not arrive prior to 7:00 AM - Day of show entries from 8:00 AM to 8:45 AM.
 Saturday/Sunday: Puppies will begin at 9:00 AM followed by Juniors, Altered, Intact and Best of Breed
 Half hour break between shows (entries open) – second show will not start before 11:30 AM. Site closes at 6:00 PM

CLASSES OFFERED:

Junior Handling: Pee Wee 3-5, Sub. Junior 6-7, Novice 8-12, Open 8-12, Novice 13-17, Open 13-17.

Conformation: Non-regular (divided by sex): 2-4, 4-6, Best of Breed Puppy.

Regular Classes: Altered & Intact Conformation (divided by sex): 6-9, 9-12, 12-15, 15-18, Novice, American Bred, Bred by Exhibitor, Open Blue Merle, Open Red Merle, Open Black, Open Red, Winners and Best of Breed.

HOW DO I GET THERE?

Directions: 5380 Dehesa Road, El Cajon, CA 92019

From the North: Take I-5/I-805/I-15 South to I-52 East to 52 West to I-8 East, exit Second Street and turn right (Second Street will become Jamacha Road). Go to the 5th light (Washington) and turn left. Washington will become Dehesa Road – follow Dehesa Road to the 2nd light (about 6 miles at a gas station) – turn right – this will keep you on Dehesa Road. From the stop sign Reggie field is just under 1 mile on the left – look for “Reggie Field” sign. If you get to the “flashing lights” or casino entrance you have gone too far. If you get lost call Richard at 619-857-7822. Entrance for parking is **PAST** the house driveway and doggy mailbox about 60 feet.
