Handlers meeting: at 7:30am, AM Trial to start at 8:00am, pm trial to follow

Classes offered: Advanced, Open, Novice, Started, & Juniors

Awards Offered: Qualifying ribbons and placements 1st – 4th

Awards also offered for HIT cattle, HIT sheep, HIT ducks, HC WTCH Aussie, HC Non WTCH Aussie, HC Other Breed, and High Combined Started Aussie.

Fee's: Pre-entry: Cattle \$60 Sheep: \$45 Geese: \$35
Post-entry: Cattle \$65 Sheep: \$50 Geese: \$40

Package Deal: Any dog entered in all 6 trials, on all stock, \$720.00

Entries will be accepted as per ASCA rules and must be on official ASCA entry forms. Both can be found at www.asca.org

Opening date: Feb 10th, 2023

(no entry will be accepted if postmarked prior to the opening date)

Closing date: March 15th, 2023

(any entry post dated after the closing date will be accepted at post-entry price if space allows)

Any entry postmarked after March 15th, 2023 will be charged at the post-entry rate. In the event of duplicate postmark dates, a drawing will determine which entry will be accepted. Checks not honored by the bank do not constitute a valid entry. Refunds will not be made after closing date unless the entry is filled from a waiting list. Run orders determined by random draw in advance of the trial. Bitches in season will run in the order drawn. Substitutions will be allowed. Day of trial entries, if available, will be taken at 7:00 -7:15am each day for both trials that day. \$30 service charge for returned checks. Please provide email address for entry confirmation.

Dogs not reg with ASCA must have a tracking number if they want to earn titles and have their Qs tracked.

Note: checks will not be cashed until trial date

WELCOME TO HERDING AT BEAR VIEW RANCH!

LOCATION

Bear View Ranch is located at 4602 S. Hills Valley Road, Orange Cove, CA, approximately 25 miles east of Fresno. The Ranch is not close to any stores or restaurants so bring your own food and beverages.

DIRECTIONS

Your GPS may not give you the fastest directions to Bear View Ranch. Get on Freeway 99 to Fresno. Take Freeway 180 east going towards Sequoia Kings Canyon. 19 miles after the Clovis Avenue exit, turn right on Cove Avenue. Take Cove Avenue 4 miles to the stop sign at American Avenue (there are tall radio transmission towers on the corner). Turn left on American Avenue. Go 2 ½ miles on American Avenue to Hills Valley Road. Turn left. About half a mile on your right, you'll see some tall cypress trees and the entrance to Bear View Ranch. Enter the gate with the sign (photo below). The gate keypad is on your left. **The gate code is: 4747#**



RULES AND POLICIES

1. Dogs must be up to date on rabies vaccines.
2. Dogs must be kept crated and/or **on leash at all times** except when actively working livestock.
3. Owners must clean up after their dogs and deposit waste in appropriate receptacles provided for that purpose.
4. No smoking on the premises. Cigarettes and cigarette butts pose a fire and safety hazard.
5. Plan to crate out of your car or bring shade for you and your dog and a chair for you.
6. There are no stores close to Bear View Ranch. Bring any food or water you might need. Pack it in, pack it out. Please do not litter. Take water bottles, beverages, food, gum, and any other items you bring home with you.
7. Aggressive dogs such as dogs posing risk to people, other dogs, or livestock, will be removed from the premises. Removal of a dog, handler, or any other person is at the sole discretion of Bear View Ranch; its owners, Cynthia and Tom Downing; and its herding instructors including, but not limited to, Tammy Domico and Betsy Cambareri. If a dog or person is removed for aggressive or abusive behavior, refunds of any monies paid for herding shall not be made.
8. Abuse of any kind directed towards the owners, herding instructors, volunteers, other participants, observers, and/or the livestock will not be tolerated.
9. In more than a decade, no livestock have died while herding at Bear View Ranch. However, if any livestock die while a dog is working the livestock, the dog's owner is responsible for paying the FULL cost of the current market value of the livestock.
10. All owners and/or dog handlers must sign a Waiver and Release of Liability and Assumption of Risk. The Waiver will be available for you to sign when you arrive at the ranch.
11. Please do **NOT** post videos of dogs herding sheep, goats, or cattle to any public social media. PETA is active in our area and we do not want them to know we exist. PETA members have been known to let livestock out of corrals and pastures in an attempt to stop the use of livestock by humans. We want to avoid this at all costs.
