Directions to park:

From I17 take HWY 169 exit to Prescott. Turn right onto Fain Rd. Continue onto SR – 89A South, Turn left onto Willow Creek Rd. Turn left into Willow Creek Park.

Day of Show parking is free

Set up can begin at 7:30 am on Saturday. This is a **self-cleaning show**, please keep area clean, including hair.

Show site is located in a public but fenced area, please secure valuables. Setups can left overnight. Bring Shade, tie-downs, and generator if you need power. Restrooms are available. No food vendors onsite. Restaurants & shopping are nearby.

Trial held outdoors. Ring surface is grass.

Be prepared for wind & any type of weather. Bring tie-downs & shade.
