Directions to Tucker Creek Farm: GPS 48.308, -89.391

From Thunder Bay: head south on Highway 61 towards the US border. We are 6.5 miles / 10.5 km past the airport, 1 km past the Neebing Roadhouse. We are the first driveway on the right hand side just past Re-Cool Recycling and across from DeBruins Nursery.

From the US border, heading north on Highway 61 we are approximately 28 miles / 46 km from the border towards the city of Thunder Bay. The address is 3020 Highway 61, on the left, just after you pass Gillespie Road, and opposite DeBruins Nursery. If you see the "Welcome to Thunder Bay" sign you have just passed our driveway. 😊

Please pull off the sides of the driveway. Please pick up after your dogs and put the bags in the garbage cans provided. There will be either a luncheon or concession for the trials. BBQ, snacks and refreshments will be available for sale.
