All ASCA Stock Trial Rules will be followed.
Open to all ASCA Recognized Herding Breeds.

Trial Location: Oslie Farm - W13301 Young Road, Black River Falls, WI 54615

Judges: James Berget & Devona Pierce

Entries: Cattle -- Pre-entry: \$50 Gate entry: \$60

Sheep -- Pre-entry: \$45 Gate entry: \$55

Ducks -- Pre-entry: \$35 Gate entry: \$45

Weekend Package: All six trials, all classes of stock, same dog - Pre-entry: \$745

All non-ASCA registered Aussies/other herding breeds must have an ASCA Q tracker number.

Handler's meeting: 7:30 am each day with trial beginning immediately after.

Classes offered: Started, Novice, Open, Advanced, Working Junior, FEO

Daily Maximum Runs: 20 Cattle, 25 Sheep, 20 Duck. Number of head per run will be 3-5 head sheep and cattle, 5 head ducks, to be determined by number of entries.

Pre-entry for Australian Shepherds opens August 16, all other breeds August 21.

No entries will be accepted if postmarked prior to opening date. No electronic entries.

All entries must be on the most current ASCA entry form found at asca.org/wp-content/uploads/2016/04/stockdogentryform.pdf

Pre-entries close September 15th. Gate entries will be taken prior to the Handler's Meeting each day if trial is not filled. Run order will be drawn prior to trial.

No refunds after closing date unless trial is filled and there is a wait list.

Bitches in season will run in order but must be kept away from the arenas when not running.

Stock to be Used: 5 head per run of ducks, 3-5 head per run of sheep, and 3-5 head per run of cross bred beef cattle. Cattle will be dog broke (have been exposed to dogs). Owners of dogs will be held responsible for all injuries to livestock during their runs. Replacement costs are: \$50.00 per duck, \$200 per sheep, and market value per cow unless posted otherwise at time of trial.

Day of Trial Information:

- Draw (Run Order) will be posted prior to start of trial.

- All dogs must be on leash or crated when not competing. (Flex leads are not permitted on the grounds)
- Harassing of stock will not be permitted - run may be called by judge or stock owner.
- Changes and/or substitutions, other than natural division progressions, must be submitted to the trial secretary in writing the evening before the trial.
- Move-ups are allowed with written notification to the trial secretary prior to the start of the trial.
- Entry fees will be refunded only when a dog has been certified by a licensed veterinarian as unable to compete due to sickness or injury. Owner will be responsible for all vet fees.
- All entries must be on ASCA® entry forms with proper fees included.
- Please use one entry form per dog.
- Note that the T1, T2, or T3 designation on a trial does not indicate or restrict the order in which the trials will be held.
- If the trial is full and you wish to sell a run and there is a waiting list, the transaction must be handled by the trial secretary. All offers to sell runs must be submitted in writing at least one hour before the trial starts. No exceptions.
- Selling runs individual to individual will not be permitted.
- Run limits and judging assignments are subject to change.

- **_Individuals will be responsible for any damage done to the stock and /or equipment. ASCA®, 3 Sheeps Australian Shepherd Club, and its club members will not be responsible for any loss, damage or injury to persons, dogs or equipment of any competitor or spectator.**
