NOTE TO OBEDIENCE COMPETITORS: THIS IS NOT A MATCH. All dogs will be competing for obedience titles through ASCA®. Each entry form must have a current registration number (ASCA® or recognized registry) and be completely filled out, no exceptions. If your dog has earned a title through any other registry, but not ASCA®, your dog will be required to begin in Novice.

Tracking Fees for Non-ASCA® Dogs: All non-ASCA® registered dogs will be required to have an ASCA® Tracking Number. This is a one-time fee of \$20.00 per dog. At the time of applying for the tracking number, the individual owner must also be an ASCA® member (Service member fee-\$20.00). ASCA® membership does not need to be maintain in subsequent years. You will be able to apply for a tracking number the day of the show, if your dog does not have one. GENERAL SHOW AND SITE INFORMATION

- Show Site is indoors with heat, and a thick matted floor.
- **The show building will open at 2:00 pm on Friday, Nov 24, 2023; at 8:00 am on Saturday, Nov 25 & at 8:00 am on Sunday, Nov 26, 2023 for ALL Exhibitors**
- No equipment is allowed in the building prior to 2PM on Friday,
- There is very limited crate/grooming space & electric outlets in this building. Please be courteous to fellow exhibitors.
- **You will be required to stack crates if necessary. NO soft crates allowed in the grooming area. Limited Groom Tables per exhibitor due to limited space. Soft crates are allowed in the exhibition area in designated areas however this space is limited,**
- NO X Pens Allowed; crates/grooming tables must be on a protective mat
- ABSOLUTELY NO CHALKING ALLOWED!!!
- NO GROOMING ALLOWED IN THE EXHIBITION AREA !
- NO FOOD, BAIT, CRATING or SEATING allowed within 10 feet of the performance ring,
- There will be NO reserving or holding set up space at this facility.
- ALL exhibitors are required to keep their grooming & crating area clean!
- NO dogs are ALLOWED to be left in the show building unattended.
- EXHIBITORS ARE REQUIRED TO CLEAN UP AFTER THEIR DOGS!
- IF NOT picking up you will be asked to leave with no REFUNDS!
- All dogs and equipment must be removed from the building within ONE HOUR after the conclusion of the show/trial on Sunday, November 26, 2023 or you will be charged a rental rate of \$50.00 per hour for the building.
- **NO CAMPING or OVERNIGHT parking allowed at site!**

From South I 94 – Exit 40 on to East US 20

From North– US 39; left on US 20, right on N175E, which changes to 150 E. site on left

From East– West US 20; left at stoplight at N450E, turn right on US 2, right on 150 E.

From West – From LaPorte, go East on US 2 turn left on 150 E; site is on right

From South– Take US 2 East through La Porte, left on 150 E; site is on right.
