All entries must be on a current ASCA entry form. Please fill out a separate entry for juniors and conformation classes. Any dog over 6 months must have a permanent ASCA number.

**This show will be held under the current rules and regulations of ASCA.**

No entry shall be accepted from a dog or handler disqualified from the ASCA conformation program; a dog or handler disqualified from all ASCA programs: or a person not in good standing with ASCA.

**Jr. Handling:** Pee-Wee 3-5, Sub Jr 6-7, 8-12 Novice, 8-12 Open, 13-17 Novice, 13-17 Open, BJH

**Non-Regular Classes** (Divided by Sex): 2-4 Month Puppy, 4-6 Puppy, BOB Puppy

**Regular Altered & Intact** (Divided by Sex): 6-9, 9-12, 12-15, 15-18, Novice, Am. Bred, Bred-By, Open (Divided by Color), Winners Dog, Winners Bitch, Best of Breed

**Awards:** Ribbons 1<sup>st</sup> – 4<sup>th</sup> Place, Rosettes, awards all shows, all days.

**Driving Directions:**

**From North:** take I-15 exit 325. Turn right onto Park Lane. Go to the roundabout and take the 3<sup>rd</sup> exit (Eastbound Clark Lane). Turn right (South) on to the road between the DMV and Correctional Center. Follow the road past the horse barns and blue buildings. We are in building #3 (South building).

**From South:** take I-15 exit 322. Continue to the stop light and make a left. Follow road over freeway and continue straight through the next light. Turn left (South) on to the road between the DMV and Correctional Center. Follow the road past the horse barns and blue buildings. We are in building #3 (South building).
