Classes offered

- Junior Showmanship: Pee Wee, Sub Jr, Novice and Open 8-12 & 13-17, Best Junior Handler.
- Puppies: 2-4 months and 4-6 months, divided by sex, merle and solid, Best of Breed Puppy.
- Veterans: 7-9, 10-12, 13 and over, divided by sex, Best of Breed Veteran.
- Intact and Altered: 6-9, 9-12, 12-15, 15-18, Novice, American Bred, Bred By, Open Blue Merle, Open Red Merle, Open Black, open Red. Classes divided by sex. Winners Dog, Winners Bitch, Best of Breed.
- Awards: Ribbons 1st-4th, Rosettes and Awards for BJH, RJH, BOBP, BOBP, BOBV, BOBV, Altered and Intact WD, RWD, WB, RWB, BOB, BOB, BOW. Intact and Altered Premiers will be offered based on 15% of the entry with a minimum of 2 per sex.

GENERAL INFORMATION

This is an ASCA sanctioned event and will be held under the current rules and regulations of ASCA and the 2024 ASCA National.

No entries can or will be accepted for a dog, handler or owner disqualified or not in good standing with ASCA.

Please use a separate entry form for conformation and juniors.
Do not send registration papers, but have them available if needed.

Age of all dogs will be calculated as of October 11, 2024.

No entry fees will be refunded. Returned Checks do not constitute a valid entry.
There is a \$40.00 service charge for any returned checks for insufficient funds or otherwise.

This is the first pre-show and is held on a condensed schedule as directed by the facility and the National Host Club. Therefore, we are required to start Best of Breed Intact Dog Groups prior to the completion of the Intact Class judging.

On-site entries will be accepted and taken on a first come, first serve basis,
Friday Oct 11, 2024 from 5:00pm - 7:00pm, in the Pinnacle Bank Expo Center.

Amber Jade will be the event photographer.

Show start time will be **8 AM**, Saturday, October 12, 2024.
Schedules will be available at check-in with updates posted at the rings in the morning.

Limited, temporary ringside crating will be available, but **NO** grooming in and around the Pinnacle Bank Expo center. Exhibitors must comply with National rules.

Judges will not wait for any dog holding up a class, with the exception of the Bred By Class. Those with conflicts should make the ring steward aware **PRIOR** to the class.

Any Owner, Handler or spectator being abusive towards a dog or exhibiting poor sportsmanship, will be asked to leave the shows site for the duration of the show.

Building open times are the same as in the National Specialty premium.
Rings will be inside a climate-controlled building. Surface will be mats over concrete.
