SHOW LOCATION | DIRECTIONS | SHOW NOTES

Rio Conservation Club W5950 Gorman Road, Rio, WI 53960

From the South: I-90/39 North to Exit 132 (US-51). North on 51 for approx 10.4 miles to Hwy 22. Hwy 22 for approx 9.7 miles to Gorman Rd. At stop sign continue on Gorman Rd about ½ mile until you see the Rio Conservation Club. Turn left in the driveway and follow it up the hill.

From the North: I-94 to Exit 106 (Hwy 33). Hwy 33 to downtown Portage. At the stop light take a right on Hwy 16 towards Rio/Wyocena. Approximately ½ mile after passing under the Hwy 22 bridge turn right on Traut Rd. Take Traut Rd. to first intersection and turn left on Gorman Rd. about ½ mile until you see the Rio Conservation Club. Turn left in the driveway and follow it up the hill.

From the East: Hwy 16 from Columbus and go approximately 19 miles (past Rio). Just when you see the Hwy 22 bridge ahead of you turn left on Traut Rd. Take Traut Rd. to first intersection and turn left on Gorman Rd. about ½ mile until you see the Rio Conservation Club. Turn left in the driveway and follow it up the hill.

- Entries on official ASCA forms only. ASCA entry forms can be downloaded at: www.asca.org/forms/index.html
 - No show photographer will be available.
 - This show is on grass and will happen, rain or shine.
 - Grooming is outdoors with no electricity available.
 - No overnight parking, RVs are welcome with no hook-ups available.
 - All Aussies over six (6) months of age may be asked to show proof of ASCA registration. Be prepared to present registration papers on all dogs six (6) months of age or older as of the date of the show.
 - All dogs may be asked to show proof of rabies vaccination. In that event, a certificate from a licensed veterinarian is required.
 - Any dog that displays viciousness toward people or animals at any time on the show premises will be ejected from the show site for the entire show weekend with no refund of entries.
 - Physical abuse of any animal will not be tolerated. Any person on the show site reported to have physically abused an animal will be ejected from the show site with no refund of entries and will be subject to disciplinary action per ASCA rules.
 - No puppies less than 8 weeks of age are allowed on the show site. Absolutely no puppy sales allowed on the show grounds.
 - There will be no refunds in the event that a dog and or handler are dismissed from competition, regardless of the reason.

*This is an ASCA sanctioned (pending) event and will be governed by the rules of the Australian Shepherd Club of America®.

- A 100% refund will be given for any request received prior to the closing date. NO REFUNDS AFTER CLOSING DATE. Checks not honored by the bank do not constitute a valid entry fee. There will be a \$35.00 service charge for bank returned checks.
- Pursuant to ASCA rules, any dog displaying clinical symptoms of a communicable disease will be removed from the trial site, with no refund of entries. In the case of removal of a dog that shows symptoms of any contagious disease, all dogs in the same household or traveling with said dog shall also be removed.
- RRVASC, its Board of Directors, ASCA, its Board of Directors, and the property owner assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers or to any of their dogs, personal property and/or children.
- Dogs must be on leash at all times.
- CLEAN UP AFTER YOURSELVES AND YOUR DOGS. GARBAGE CANS ARE READILY AVAILABLE. *Anyone caught not cleaning up after themselves or their dog (indoors or out) is subject to ejection from the show site, no refund of entries.*
- Do not leave dogs unattended on grooming table.
