**General Information:** This is an ASCA sanctioned show and all ASCA rules apply ([www.asca.org](http://www.asca.org)). Dogs over 6 months of age must have proof of ASCA registration available and proof of Rabies vaccination. High Plains ASC, the Show Secretary/ies and Club Membership and its Officers assume no responsibility for any loss, damage or injury sustained by an exhibitor, handler, dog, property, children or spectator. All dogs must be crated or leashed at all times, except when competing in the ring during “off-lead” work.

Entry Fees will not be returned if the show cannot be opened or be completed due to riots, civil disturbances, acts of God, public emergencies, COVID flare-up, or other events beyond the control of High Plains ASC. Entry fees will not be refunded if the dog is absent, disqualified, excused, or barred from competition by the Show Committee, ASCA, show veterinarian or the judge. No entry shall be accepted from a dog or handler disqualified from ASCA programs or a person not in good standing with ASCA and/or High Plains ASC.

**Bitches in season are NOT allowed to compete in the Obedience Trial(s). Bitches in season are NOT allowed to compete in the Rally Trial(s).**

**PRE-ENTRY DEADLINE:** Pre-Entries must be postmarked no later than **June 25, 2024** to qualify for Pre-Entry Fee Rates. **PLEASE KEEP IN MIND, U.S. MAIL DELIVERY TIMES ARE VARIABLE; MAIL YOUR ENTRIES IN PLENTY OF TIME TO REACH THE ENTRY CLERK.** HPASC is not responsible of unreceived entries. Telephone, facsimile, e-mail, or incomplete entries will not be accepted. All entries must be on the most current version of the official ASCA entry form with proper fees included. Exhibitors are responsible for the accuracy of the entry and class(es) entered. Withdrawals of entries will be accepted until the pre-entry closing; thereafter, no refunds will be made.

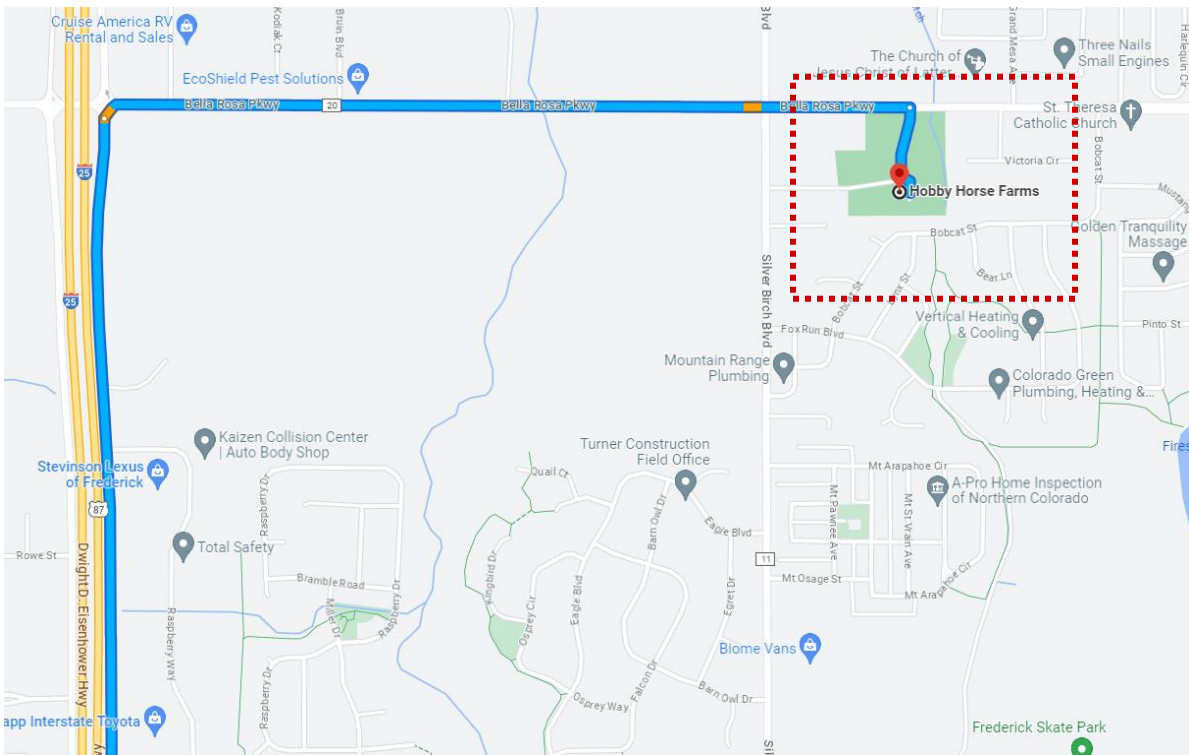
